Public Hearing Opened at 9:01 a.m.

Georgia Macnab, Planning Department and Nelson Unsworth, representing Actualize Events, gave an overview of the proposed mass gathering permit.

The purpose of the hearing is to consider an application for a Mass Gathering Permit proposed by Actualize Events LLC represented by Nelson Unsworth. The mass gathering is scheduled to be held on October 13-16th, 2022, on property owned by Justesen Ranches. The site is on Twin Lakes road, 4 miles south of Grass Valley and described by the Sherman County Assessors maps as T3S, R16E, Section 21, Tax Lot 2800.

Actualize Festival is a music and art event. The focus is to give musicians and artists in the Northwest a platform to showcase their craft. The event will consist of camping, music, art showcase, a few talks and some workshops. They are expecting around 400 people including staff to attend the event.

Notice was sent to the surrounding property owners and agencies 10 days prior to the hearing. Agencies notified were: Sherman County Sheriff, Sherman County Road Master, North Central Public Health Department, City of Grass Valley, South Sherman Rural Fire, and Sherman County Emergency Manager.

The Planning Department has received no comments as of today (9-7-2022).

Judge Dabulskis asked if there were any comments from anyone in the audience or on-line. There were no comments.
