Dana Pursley-Haner, Emergency Services Manager, came to County Court to discuss the updated Emergency Operations Plan (EOP). Dana explained that the EOP is updated every 4 years including: school buildings, personnel throughout the county, equipment inventory for the road department and all fire departments, mutual aid agreement (no transporting) with ambulance for North Sherman Fire.

3.1 Bus Barn

Bus Barn application is due at the end of month. Consensus of County Court is that Justin can sign Letter of Intent for the application.

3.2 VA Memorial

County Court discussed donating \$1,000 to a Vietnam War Memorial on the Oregon State Capitol Grounds in Salem Oregon.

3.3 Library

Proposed additional language to the draft IGA submitted to the school District for the Public/School Library. Wording was send to our legal counsel to submit to school legal counsel.

Funding. The County agrees to provide \$100,000 per year for the addition cost needed to provide public library service. The district will shall determine the cost of personal. The Library Board shall determine programs, materials, cost and the budget needed to provide for public library service, as per ORS 357.490 with the exception of #1. In addition, the County agrees to provide \$3,000 per year to the district to supervise library employees during school vacations.

Hours. The District agrees to keep the library open for public library service for a minimum of 20 per week. 4 of the 20 hours will be after school hours during the week and 4 of the 20 hours will be during the weekend. This will exclude any times of disasters, manmade or natural, at the call of District, County, or Library Board.

Judge Dabulskis would like spend a day with the different positions within the county so that he can better understand the duties and routines in the different jobs.
