Present: Debbie Hayden, Karl Ihrke, Drew Messenger, Brittany Dark

Debbie Hayden, Sherman County Finance Officer, came to County Court to ask a few questions about budget for next fiscal year so that she can finish preparing the budget for the budget committee meeting.

- NORCOR is asking for a 7% increase
- Library is asking for \$50,000
- Extension is asking for a 24.5% increase
- Resident Incentive Program we have been adding 5% each year. Currently, there are funds to keep this program going for an additional 10 years. Do you want to keep adding the same percentage for the 2023/24 fiscal year? County Court does want to keep adding the same percentage to the Resident Incentive Program for the 2023/24 fiscal year.
- For Biggs Budget Debbie will put \$500,000 as a place holder as the amount that will be spent on the Biggs Water project for the 2023/24 fiscal year.

Debbie also mentioned that Avangrid has called to question payments on the Golden Hills Community Service fees or SIP additional fees. They thought that they were following the 2017 rules even though the contract didn't get signed until late 2018.

Kelsi Phillips, Sherman County Transportation Director, came to County Court to give her quarterly report. Kelsi reported that there is currently \$480,000 for the bus barn project and she has applied for another \$600,000 in grants.

Kelsi stated that she is going to surplus vehicles number 7 and number 10 soon. Both vehicles are at APEX now getting ready to be surplused. Kelsi mentioned that she is not looking to replace either of these vehicles right away. She will hold onto the money and replace another vehicle in a few years.

Wes Owens came to County Court to give his Sherman County School quarterly report as follows:

- May 15 upcoming budget meeting
- Currently in negotiations with Certified and Classified staff.
- Hired a Nurse, Matt Bagwell.
- Passed a policy on NARCAN and Matt will be able to administer if needed
- Oregon Department of Education State testing underway
- Discussions on a 4 day school week did not pass but the school board did approved a modified 4.5 day week.
- Transportation contract with North Wasco School District is a great fit and is working well. This is a three year contract.

Commissioner Bird thanked Wes for all his hard work on the IGA for the Public/School Library.

Fritz Bachman, Community Corrections Quarterly Report 1.5 10:15 a.m.

Fritz showed a PowerPoint and discussed the philosophy behind community corrections. Fritz explained that you need to have patience, rapport and empathy with the clients in order for them to trust you.

Fritz talked about the different residential housing available to clients. Fritz stated that no client with sex offences, arson crimes, or severe mental health issues were eligible to live in these houses and clients with assault crimes were looked at on a case by case basis. The first house has a house manager, peer mentors and room for up to 12 residents.

The second house is also a residential house but it has less rules. The thought behind this is to ease the clients into residential living where they follow strict rules at first like they did in jail/prison and then as they transition in to the other house the rules get more lenient and they can make more choices on their own getting them ready for independent living.

Judge Dabulskis thanked Fritz and his team for all that they do.

3.0 Discussion Items

3.1 Preschool/Daycare Budget

Looking at the three applications received, the total ask is \$108, 334. This is \$8,334 more than what is budgeted. The question that County Court is pondering is whether to leave the amount as is or to ask the Budget Committee to give a little more to this fund.

County Court did not make a decision on this topic today.

The WIR District has money that they are donating to education and Debbie is waiting to hear if they are going to donate to this line item. This could cover the extra costs requested.

3.2 Frontier 911

Judge Dabulskis stated that there is no real update on Frontier Regional 911 at this time. Judge Dabulskis will be having a meeting with Wasco County later today. He also had a meeting with Jefferson County last week. One suggestion that came out of that meeting by Jefferson County was to set up two 911 consoles for day time use in Jefferson County to help with the volume of calls that come from Jefferson County.

3.3 Legal Counsel

County Court has used Meredith Smith's legal services for a 90 day trial period when attorney Jeff Wallace stepped down as County Legal Counsel for personal reasons. Now that the 90 day trial period is over, County Court would like to sign a Personal Service Agreement for Legal Services with Timmons Law PC and Meredith J. Smith as County Legal Counsel.

Meredith drew up the Personal Services Agreement for both Sherman County Court and Biggs Service District to sign with a note that her hourly rate will be \$285.00 an hour which is slightly higher than our previous contract.

Kent Water project update - Liz Mills reported to Commissioner Bird that the surveyor couldn't find the land markers to determine plot lines, but Todd Mills was able to find the markers and took pictures and sent the pictures to the surveyor. Liz has not heard back from the surveyor yet.

Commissioner Miller- Attended a Fair Board meeting; and an Avangrid meeting.

Judge Dabulskis - Attended an Avangrid meeting; a NORCOR work session; an Eastern Oregon Caucus conference call; AOC Legislative Committee meeting; AOC Board meeting; NACA meeting; CREA meeting in Prineville; went to Wilsonville and attended a meeting on alcohol awareness through CIS; a Frontier Regional 911 meeting; and VSO interviews.

3.7 **NCPHD**

Commissioner Bird talked about North Central Public Health District (NCPHD) and the changes that are ahead. NCPHD has been in the beginning conversation stage with Wasco and Sherman County to potentially dissolve the current IGA (Intergovernmental Agreement) for the Health District and move public health services back under Wasco County as a department and contract public health services with Sherman County. This would mean that Sherman County may need to pay Shellie Campbell, current Director of NCPHD, a fee for her services as counties are required from the state when establishing a public health department to hire a public health director.

Commissioner Bird asked County Court a few questions and will take the answers back to the NCPHD's next meeting.
