9:00 a.m. Eric Akin – Veteran's Service Officer Meet and Greet Present: Eric Akin, Brittany Dark

Eric Akin came to County Court to meet the Commissioners and give County Court an update as to what he has been doing in recent months. Eric stated that he had been training the new VSO in Hood River and he is officially done with that training.

Eric stated that he and two other VSO's from the Gorge area will be at the Veterans Stand Down event on Wednesday, September 20^{th} , 2023 from 9:00 am -2:00 pm at The Dalles Civic Auditorium. This is an exclusive event for Veterans and their families. Veteran Services will include: housing resources, employment resources, mental health and substance use resources, healthcare resources and much more.

Eric stated that in the Tri-County area he has been focusing on:

- Setting up all three offices to be more of a paperless model reducing the number of filing cabinets needed
- No longer using separate phone numbers for each office and is only using one cell phone for all phone correspondence.
- Launched Veterans Facebook page.

- New business cards
- Is part of the Memorial Day Planning Committee

Eric mentioned that he had a carryover of \$12,000 from last year and he is using some of that money for the following:

3.5 Commissioner Reports and Updates

<u>Judge Dabulskis</u> – Attended a 4 cities meeting along with Representative Smith; rode around with Joe Farnell looking at internet possibilities; gave Representative Smith a Tour of Sherman County; met with Alan Hickenbottom regarding resiliency project.

Judge Dabulskis stated that while he was at the 4 cities meeting they discussed the recycle bins. Judge Dabulskis let everyone know that the County owned the recycle bins and had insurance on the bins themselves, but that the recycle bins were on city property so everything else including the steps to the bins were city property and the cities were responsible for maintenance of everything besides the bins on the site.

<u>Commissioner Miller</u> – Visited with Representative Smith. Fair board is looking for a new secretary.

Commissioner Miller has talked with a couple of residents who have voiced concerns regarding increased risks at state parks. The residents stated that the more state parks are advertised, the more the risks increase and our services are already stretch thin. In 2023, Cottonwood Canyon State Park has had to deal with multiple fires and a drowning. The idea of more people in the state parks is concerning.

<u>Commissioner Bird</u> – Attended a NCPHD outreach meeting with Deanna Christiansen, Caitlin Blagg, and Martha McInnes; Mid-Columbia Community Action Council meeting; Mid-Columbia Housing Authority meeting, met with NCPHD Director; and a Mid-Columbia Center for Living meeting.

Commissioner Bird asked for a Frontier Regional 911 update. Judge Dabulskis stated that there is no update as of now. The next Frontier Regional 911 meeting is September 12th, 2023.

Rufus Food Pantry – Brittany Dark introduced the new Rufus Food Pantry Director Fred Fahrni. County Court toured the Rufus Food Pantry that is being remodeled due to a flood that ruined the flooring and asbestos needed to be removed. County Court also toured the room that the Rufus Food Pantry will be using for dry goods only until the old room gets fixed.
