Q: Can applicants jointly apply?

A: Yes that is possible. Brand Gov will not be able to apply, unless they partner with a nonprofit. For-profit companies cannot apply for this NOFA. The partnership must be clearly stated in the proposal.



Q: Were you looking for us to provide a full work plan?

A: Attachment A has proposal questions detailed (description of activities, need for activities, intention of funds, timeframe, activities are equitable and conclusive, and reaching hard-to-reach audience, qualifications and sustainability efforts, key personnel, additional funding sources during grant period, etc. Maximum of 3 pages.) Stating "without further funding we would not be able to sustain activities" is perfectly fine.

Q: Please go through the evaluation process slides.

A: High-level overview. Solano County will be the final decision-maker. Please submit all questions to Linda and/or email. All questions and answers will be posted on the Solano Connected website January 10th.

Q: Which project can we apply for?

A: Propose a project in either project objective shown (Digital Literacy and Education & Affordable Connectivity Program)

Q: Can this grant help cover hardware specifically for ACP events?

A: Yes. Hardware and materials for ACP are acceptable. The bulk of the money should be for the program, but 15% indirect funding can cover administrative expenses.

Overview: Meeting to discuss ARPA-funded RFP for digital equity in Solano County.

Nonprofits can apply, and for-profit partnerships are allowed. A narrative proposal required, with a focus on digital literacy/education or enrollment services. Hardware expenses must be part of a program.

Summary:

- The purpose of the meeting is to address any questions related to the RFP (Request for Proposal) that was issued through a notice of funding availability using ARPA funds.
- Applicants can ask for less than the minimum amount specified in the RFP, but it may not be viewed favorably.
- Nonprofits can form partnerships and jointly apply for the RFP, but for-profit companies are not eligible to apply directly.
- The application requires a narrative proposal that includes a work plan, description of activities, description of need, use of funds, equity and inclusivity measures, multilingual and multicultural programming, engagement strategies, qualifications and sustainability efforts, and potential additional funding sources.
- The funding streams for the affordable connectivity program include digital literacy and education services, as well as enrollment services. Applicants can choose to focus on one or both of these components in their proposals.
- This grant does not specifically exclude hardware expenses, but it is important to demonstrate how the hardware will be used as part of a program or initiative. Simply buying hardware without a program wrapped around it may not be considered eligible for funding. For example, The Area Agency on Aging and Meals on Wheels are providing hardware (iPads and Samsung tablets) to senior citizens, but there is a need for teaching them how to use the devices.
