## SOLANO COUNTY REGIS MEETING

Meeting Minutes - September 21, 2022

Curt called to order the regular meeting at 9:05 am on September 21, 2022 via MS Teams.

#### I. Introductions

## II. Approval of Meeting Minutes and New Business

- A. June Meeting Minutes (no meeting July-August) No comments nor questions, moved to approve.
- B. Vacaville updating RIMs, wants to work with the County and other agencies, data architecture, schedule updates, etc. County working on a monthly framework per GTG updates, OES environment, FTP to download data layers public facing and password protected portal. RIMs is different per agency and will be a challenge to standardize.

### III. Discussion:

#### A. Sanborn presentation - Bridget

- 1. Everyone should have access to Sanborn Geoserve, Daniel will send out list with credentials.
- 2. Each city should review the tiles by October 20. Provide city boundaries, KCl to do additional reviews. Hope to have many eyes to review the data.
- 3. Any questions about the data, forward to Bridget and/or Daniel M.

#### B. Lidar Workgroup – Daniel

- 1. Waiting for USGS open announcements in October for <u>3Depth</u> funding, will use 3D's QC standards, working with Sanborn for 3D funding, adding to the USGS' pool of interested agencies to collaborate.
- 2. Use lidar data generated by Quantum Spatial 2017, ql2 and merge into County data. Getting quotes to serve out on portal, approvals towards the end of the year.
- 3. Curt/Sean volunteers to assist in the group. Lidar benefits all agencies.
- C. CalOES Daniel. North Delta exercise, 5 counties involved, some agencies were not informed. 117 data layers in one application, slow response, will rebuild functional internal system and another archival data analysis.

- 1. County would like to develop a countywide list of contacts for announcements such as training of OES. Daniel meets with OES monthly.
- 2. Zonehaven, covers the entire county to evacuate in zones. Will align with city boundaries. OES will be stewards of the data, will find out how data will be updated. Goal is to have a single comprehensive multi-jurisdictional EOC application.

#### D. Broadband update - Daniel

- 1. Vacaville conceptual plan is complete but will go through inter-departmental review.
- 2. \$4mil fund for broadband projects for digital equity, training, etc. BCG provided report there are approximately 70,000 underserved homes in communities.
- E. GIS Day event in-person Save the Date Nov 10 released. Presentations on how to access the portal, imagery, with vendors and booths, map gallery. Vendors ESRI, KCI, Sanborn, etc. **Increase awareness of GIS**. Eng'g firms to present/participate. Livecast/recordings may be available. Coffee/light refreshments and lunch provided. **Volunteers needed!**
- F. Desktop GIS Training call for volunteers. ArcGIS Pro will be first introductory training, January/February timeframe. Vacaville mix of training needs, front-end user vs production user, mobile application user, etc. Suisun interested in training.
- G. ESRI Pacific User Group Nov. 16-17 Sacramento, free?
