SOLANO COUNTY REGIS MEETINGMeeting Minutes – May 17, 2023

II. Approval of Meeting Minutes and New Business

- A. April Meeting Minutes No comments nor questions, moved to approval by Buffy, seconded by Daniel.
- B. New Business
 - 1. Daniel- Intro to ArcGIS Pro Training
 - a. Daniel will send out survey- curious about first impressions
 - b. Wynter- one of the best classes, thorough, great pace, instructor/assistant, applied lessons in real time
 - c. Roland-liked examples of county data
 - d. Travis- agreed, worthwhile training

III. Discussion

- A. Lightning Talk Rhena Berning
 - 1. Street Network Analysis
 - a. Is a spatial analytic method to looks at road networks, both current and potential markets through supply, demand and accessibility
 - b. Six types: Route, Service Area, Closest facility, Origin-Destination Cost Matrix, Vehicle Routing Problem, Location-Allocation
 - c. Suisun Fire Protection district project example. Where is the best area for a new station? example using street network analysis: Proposed 2 potential locations based on response time, gaps in service
 - d. Noted this can be performed in ESRI (uses credits) or QGIS
 - e. Questions: Brian- To calculate fastest time do linear evens need speed attribute to estimate time? Rhena =- depend is you are using street centerline or ESRI(living atlas) db. Can prioritize road class. Living atlas offers time of day, traffic, custom impedances/human behavior.
 - f. Question: Stew- could you use Network Analyst instead of AGOL credits? Rhena yes but at the time chose Living Atlas. Credits usage not much unless you are using large areas of data.
 - g. (Daniel—Rhena used 16 credits)

 - Contract with ENVI5 Quantum Spatial- purchased QL2 data 2017, QL1 2018. Contracted to merge and create derivatives: Lidar point cloud, bare earth DEM, slope, hillshade, DSM, etc. and publish services free to public
