8. PUBLIC HEARING

A. LAFCO Project No. 2023-19: Solano Irrigation District (SID) detachment of Nut Tree Apartments LLC (Vacaville) (APNS 0129-240-570, -580, and -590) — Staff presented studies for the project to detach the 12.02 acres, generally referred to as the Nut Tree Apartments, from the Solano Irrigation District. Vice Chair Vasquez asked why it took so long for this property to be detached as it has not been farmed in decades. Staff explained that although the property was approved for development some years ago, it would not be detached until a developer was ready to pay the detachment fees and construct.

There were no public comments. Com. Mashburn moved to approve. Com. Shopay seconded.

9. BUSINESS ITEMS

- A. 2024 Ad-Hoc Selection Committee for Alternate Public Member Staff presented the process for selecting an alternate public member. There was a total of six applications received. Of those six, only four are eligible applicants. The two others have conflicts making them ineligible. Staff gave the Commissioners the option to have a Selection Committee. Commissioners discussed this option and decided to move forward with interviewing all four applicants instead. The interviews will be held during open session at the April 8th, 2024 meeting.
- B. LAFCO Committee Appointments for 2024 Staff presented all the Committees needed for this year. There was a discussion about the difference between a standing and an ad-hoc committee. Com. Vasquez proposed that the Chair and Executive Officer review the budget together instead of having a Budget Committee. Staff told the board that the Ad Hoc Policy Committee will be busy this year as there are many things to go over. The Commissioners shared which committees they would like to be a part of, and the final results are as follows:

Personnel Committee – Shopay and Vasquez

Budget Committee – There will be no budget committee. Instead, Chair Kott and Staff will work on the budget together.

Policy Ad-Hoc Committee – Williams and Mashburn

Fire Reorganization Ad-Hoc Committee – Kott and Vasquez

B. Fiscal Year 2023/24 Mid-Year Report – Staff compared the approved budget for FY 23/24 and the mid-year expenses and revenues as of December 1, 2023. Staff also reviewed the approved work plan for FY 23/24 and provided status updates on the work plan items. Lastly, staff presented an estimate of the anticipated year-end budget based on currently active projects/tasks and those expected to begin before the end of the year.

No action is required. This was a presentation and discussion item only.

10. EXECUTIVE OFFICER UPDATES

Updates addressed in the presentation were as follows:

- MSR projects: Staff is working hard on the Cemetery Districts MSR. SID's MSR is in progress.
- Fire Projects:
 - 1. City of Fairfield and Cordelia District Contract: Initial application was received November 2023, but deemed incomplete in December 2023. Staff and both parties worked together to update the application and an updated application was re-submitted and is currently in review. If the application is deemed complete, the Commissioners can anticipate the contract approval request at the June meeting.
 - 2. Fire Districts Reorganization: Vacaville Fire Protection District, Montezuma Fire Protection District, and Suisun Fire Protection District will be presenting an MOU to their boards within the next month that increases the level of collaboration and promised commitment to move forward with a reorganization. Staff and the Districts continue to work on a plan for complete reorganization.
- City of Suisun: There is no update or known progress on any project EIRs, MSR, or SOI. Com. Hernandez commented that the City of Suisun is planning on having a closed session to appoint a new City Manager, once this is done she is hopeful that the new city manager will help move some of these projects along for LAFCO.
