SUBJECT: Amendment of the Conflict of Interest Code Pursuant to the Political

Reform Act of 1974

### Recommendation:

ADOPT the attached Solano LAFCO Resolution approving and adopting the amended Conflict of Interest Code pursuant to the Political Reform Act of 1974.

### **Executive Summary:**

The Political Reform Act of 1974, Government Code section 81000 et seq. (the "Act"), requires all public agencies to adopt and maintain a conflict of interest code establishing the rules for disclosure of personal assets and the disqualification from making or participating in the making of any decisions that may affect any personal assets designating positions and establishing disclosure categories.

Pursuant to Section 87306 of the Act, Local Agency Formation Commission of Solano County ("LAFCO") must amend its Code when necessitated by changed circumstances including the creation of new positions which must be designated, revision of the titles of existing positions and deletes titles of positions that have been abolished and/or positions that no longer make or participate in making governmental decisions.

Attached is a redlined version of the proposed amended Code showing that the proposed revisions are based on the establishment and recognition of new positions that must be designated.

### **Conclusion:**

It is recommended that the Commission adopt the attached Solano LAFCO Resolution approving and adopting the amended Conflict of Interest Code pursuant to the Political Reform Act of 1974.

## RESOLUTION OF THE LOCAL AGENCY FORMATION OF SOLANO COUNTY APPROVING AN AMENDED CONFLICT OF INTEREST CODE PURSUANT TO THE POLITICAL REFORM ACT OF 1974

WHEREAS, the State of California enacted the Political Reform Act of 1974, Government Code Section 81000, et seq. (the "Act"), which contains provisions relating to conflicts of interest which potentially affect all officers, employees and consultants of the Local Agency Formation Commission of Solano County ("LAFCO"), and requires all public agencies to adopt and promulgate a conflict of interest code; and

**WHEREAS**, the Member of the Commission adopted a Conflict of Interest Code (the "Code") which was amended on February 27, 2017, in compliance with the Act; and

**WHEREAS**, subsequent changed circumstances within LAFCO have made it advisable and necessary pursuant to Sections 87306 and 87307 of the Act to amend and update LAFCO's Code; and

**WHEREAS**, the potential penalties for violation of the provisions of the Act are substantial and may include criminal and civil liability, as well as equitable relief which could result in LAFCO being restrained or prevented from acting in cases where the provisions of the Act may have been violated; and

**WHEREAS**, notice of the time and place of a public meeting on, and of consideration by the Members of the Commission of the proposed amended Code which was provided to each affected designated position and was publicly posted for review at the offices of LAFCO; and

**WHEREAS**, a public meeting was held upon the proposed amended Code at a regular meeting of the Members of the Commission on August 12, 2024, at which all present were given an opportunity to be heard on the proposed amended Code.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** by the Local Agency Formation Commission of Solano County does hereby adopt the proposed amended Conflict of Interest Code, a copy of which is attached hereto and shall be on file with the Deputy Executive Director and available to the public for inspection and copying during regular business hours;

**BE IT FURTHER RESOLVED** that the said amended Code shall be submitted to the Board of Supervisors of the County of Solano for approval and said Code shall become effective upon approval by the Board of Supervisors of the proposed amended Code as submitted.
