**This item is continued from the December 14, 2020 LAFCO meeting.**

Notice is hereby given that the Solano Local Agency Formation Commission (LAFCO) will hold a public hearing at **10:00 a.m. on Monday December 21, 2020** or as soon thereafter as possible, in the Board of Supervisors Chambers, County Administration Building, 675 Texas Street, Fairfield, CA, to consider the following item:

**LAFCO Project No. 2020-06: Fairfield Suisun Sewer District-Solano County Out of Agency Service Extension for Wastewater Services to the Middle Green Valley Specific Plan (MGVSP).** The Commission will consider approval of an out of agency service extension for wastewater services to the MGVSP. The 1,905 acre project area is located north of Interstate 80, Jameson Canyon, and the Hidden Meadows subdivisions (City of Fairfield); south of existing unincorporated subdivisions and the Green Valley Country Club in upper Green Valley; west of Suisun Valley and the Rockville Hills; and northwest of the Eastridge subdivision (City of Fairfield), in unincorporated Solano County. California Environmental Quality Act (CEQA) lead agency: Solano County, Environmental Impact Report (State Clearinghouse #2009062048) certified on October 25, 2016.

All interested parties will have an opportunity to speak to the Commission in person or by phone during the hearing and may also submit written testimony prior to the hearing.
