7. PUBLIC HEARING

A. LAFCO Project No. 2023-05 Fairfield Island Annexation Phase 1 – Pittman Road, Blessed Baptist Church, Sunset Apartments (APNs: 0044-080-170, 0044-080-160, 0037-160-040, 0037-160-060, 0037-060-480, 0037-060-490) – The City of Fairfield (City) is requesting to annex about 15 acres of Solano County jurisdictional island areas. The 15 acres consist of 3 separate islands broken into 6 parcels. Staff presented the project and recommended that the Commission approve Phase 1 of the Fairfield Islands Annexation. In addition, Staff wanted to clarify that this project does not involve Suisun Valley. The Com. asked when the Phase 2 application would be completed, Christina was able to confirm that she received the application for Phase 2 that morning and that staff has 30 days to deem it complete.

There was a public comment from one of the representatives of this project, the property owner of Pitman Road, who came up to clarify that the annexation for Pitman Road has no proposed development for that property.

LAFCO Project 2023-11: Amend the Personnel and Salary Resolution by Approving the New LAFCO Project Specialist Job Classification and Related Changes to Section 4.11 Administrative Leave, Position Descriptions, and Appendix A and B; and Appropriate Funds to Fill the Position. – Staff presented the resolution to approve the new LAFCO Project Specialist Job Classification, and to appropriate funds to fill this position. Staff researched similar job descriptions to help create the new LAFCO position and salary schedule. Staff confirmed that with the new position with the proposed appropriation, the FY 23/24 budget remains balanced.

Commissioner Vasquez asked Counsel if the requires a 4/5 vote. Counsel clarified a majority vote is necessary. Alternate Commissioner Williams inquired about the position's experience requirement and if the proposed salary is competitive enough. Staff explained that candidates should have at least 5 years of experience and that the salary for this position is comparable to others within Solano County with same or similar responsibilities.
