2023 CLOSING REMARKS - Mayor Dennis Sullivan

Dear Friends, Neighbors, and Invited Guests,

As the holiday season passes into our collective memory, we gather once again to both reflect with pride on the past year here in Somerville and to anticipate the continued success that surely lies ahead.

Progress does not happen overnight, nor does it happen by accident. Hard work and thoughtful decisions by countless individuals and groups have laid the groundwork for the Somerville that we see around us today. Time constraints make it impossible to mention every positive initiative in town now, so I will limit my comments to a few of the more significant highlights of 2023.

Opportunity and optimism continue to define Somerville. People want to live here, businesses want to open here, and private capital wants to invest here. Your local government remains focused on matters of public safety, as evidenced by reduced speed limits throughout town, enhanced signage, and roadway improvements being done in collaboration with our public utility partners.

The long-awaited Emergency Services Complex on Gaston Ave. is well underway and should be in service by the end of 2024. The newly opened Somerville Civic Center has opened its doors, and over time will become the hub of civic engagement and community life so vital to the heartbeat of town.

The privatization of our sanitary sewers will ensure stable user rates and improved system operation for years to come. An aggressive tree planting program, promotion of community gardens, and innovative solar initiatives will not only beautify Somerville but shape the environment we leave for future generations. Borough parks and playgrounds are being rehabilitated with funding from all levels of government, and the return of warmer weather will bring with it the joyful sounds of children at play.

As you travel around Somerville, you will hear welcome sounds of a different sort filling the air. New buildings are rising from sites that lay dormant for too long. A stable municipal tax rate and our willingness to promote public-private partnerships are attracting quality mixed use projects that are reclaiming underutilized properties, attracting new residents, and generating additional revenue for the local budget while bringing new consumer dollars to our already thriving downtown. A changing landscape and new energy will continue to mark Somerville as a vital community that is both proud of its past and confident in its future. Quality of life may be hard to define and equally hard to measure, but it is alive and well within our two square miles. As I prepared these final remarks as your Mayor, I found myself thinking back to my first trip across the Outerbridge in early September of 1973 as I traveled west for my first day at VanDerveer School. In what was truly a lifetime ago, the bridge toll was fifty cents, gas cost thirty cents a gallon, and I had a full head of hair that actually needed combing! My new Toyota Carolla, with its ninety-eight horsepower motor, pushbutton AM radio, and manual windows, was my daily companion at the start of an adventure that I could never have imagined. Along the way I became a master teacher, a husband, a homeowner, a parent, a community volunteer, a Borough Councilman, a grandparent, and ultimately a mayor.

Over the years I had the good fortune to meet so many good and caring people with whom I worked collaboratively in guiding Somerville through a variety of economic cycles, an unprecedented pandemic, and the challenges presented by an unpredictable and often unforgiving Mother Nature. I may have come to Somerville to teach others, but I have learned a lot from those around me, and for that I will always be grateful.

I wish to express my sincerest appreciation to the voters of Somerville for their support over the last twenty-eight years. Over that time, I spent many hours at Borough Hall in meetings and doing paperwork. As I passed by the gallery of Mayor's portraits, I often thought about my role as a steward of that office and the great responsibility given me by the voters. I hope that I was deserving of that public trust and that my legacy will add to that of those dedicated men and women who preceded and will follow as Somerville continues to thrive.

I offer my heartfelt thanks to my family, and especially to Marge, my loving wife these past fortyseven years. Being married to a public official demands sacrifice, patience, and lots of leftovers, and these I had in abundance! My daughter Heather followed me into the teaching profession. I counted on her editing skills to keep my speeches short, much to the relief of the audience. And finally, my beloved Meredith, whose musical talents were often on display all over Somerville, most especially on this very stage where, fittingly, my public life concludes in a few minutes.

I end with words of encouragement to our incoming Mayor and Council. You have the hopes and dreams of many in your hands. I know you are up to the task. Trust one another and rely on your collective strength and wisdom as challenges arise.

I would offer the following advice penned by the noted American author Ralph Waldo Emerson, and often quoted by another Harvard graduate and one of my personal heroes, Robert F. Kennedy. They gave me strength in time of need, and I hope they will do the same for you: "Do not go where the path may lead, go instead where there is no path and leave a trail." Thank you.

STATE OF THE BOROUGH ADDRESS - Mayor Brian Gallagher

Citizens of Somerville, honored guests, police, fire, squad and other emergency services personnel, family and friends....welcome to the 2024 Somerville Borough Reorganization.

I'm Back!! I'm back because I love Somerville, and I commit to you today to work tirelessly to ensure that we maintain the quality of life that our residents deserve. What we have accomplished in my first 14 years as Mayor has transformed Somerville into a destination to live, work, and visit. Working across party lines, we engineered a renaissance of Somerville that will continue to benefit the residents of our community for decades to come.

However, the evolution of our borough is never done. The future requires the same visionary efforts that we employed previously, to ensure that the growth is positive and that we are prepared to accommodate all that comes with it.

I stood here exactly 20 years ago and laid out a bold vision for the future of Somerville. 20 years later the results are seen Borough wide. Our community, our 2.5 square miles of awesome, is the envy of towns statewide. We achieved our success through careful planning, public visioning, a council determined to work together, a stick to it spirit, and a shared vision of what Somerville can and should be. However, the playbook created 20 years ago should not be the same playbook we use today...it is again time for creating our next bold, community driven future for the next 20 years, and beyond.

Growth in all facets of our Borough requires those same visionary efforts, to ensure that the future is positive and that we are prepared to embrace that growth. We have great concern for safety, traffic, parking, homelessness, public works, schools, and all the other essential services that must be planned for in the coming years.

So this drives the question....What's Next? What's next for our 2.5 square miles of awesome? What's next for Recreation, Our Neighborhoods, Redevelopment, Main Street, Code Office, Public Works, our relationship With Somerset County, Housing Issues, Infrastructure, Planning....and the list goes on. To achieve continuing success, we must be goals driven. I will task each council person to work with their respective departments, and their liaison committees, to develop 10-year plans for each of their areas of responsibility.

This will create realistic, identifiable targets that can be opportunity driven, rather than reactionary responsive. It will allow the Council to develop strategies to financially phase in...or phase out...potential projects over a longer term. It will provide longer-term funding direction for all of our Departments, and it will allow us to establish priorities of wants versus needs.

I will propose an Infrastructure task force made up of Council members, county officials, and stakeholder residents who have the necessary expertise, to review and recommend to council long-range plans focusing on infrastructure. This includes roads, recreation, public works, technology, and other areas the Council sees fit. This will enable development of 10-year infrastructure improvement plan for every part of our Borough.

Our Planning Board is one of the best in the State. But it is time to stop being a bureaucratic approval body, and return to what they do best...Planning for the long-term future of our Borough.

This will require new and innovative approaches to planning and zoning. I will task the Planning Board to immediately undertake reviews of our Master Plan, our redevelopment plans, the Fair Share Housing issue, and our residential and commercial zoning. We need to enable residents to easily invest in their property without onerous regulations, inordinate plan reviews, and costs that stop a homeowner's project. We also will enable our business district to better adapt to quickly changing market demands.

There also needs to be a zoning review of all property along the length of Peter's Brook, with short range safety solutions to reduce the danger to residents and our emergency personnel. Then, long range zoning solutions can be implemented that solve the issues of residential and commercial properties in the flood areas. These solutions must respect the rights of private property owners and have the long-term benefit of a safer community for our Borough.

Our community development office is the first face of Somerville government for those who want to invest in their property, whether the homeowner, the entrepreneur, the business owner, the investor or the developer.

The process must be made easier to navigate, quickly adaptable to changing market and housing demands, informative for those that are unfamiliar with the process, and established review fees that do not deter property owners from investing in their own homes or businesses. Nothing drives people away faster than bureaucratic costs or delays. Customer service for the taxpayer, in this administration, is paramount.

We are the County Seat of Somerset County, and we have born that responsibility well. I will work with our County Commissioner partners to address core issues centering on County investment in historic, recreation, infrastructure, marketing needs, and grant funding. We will open discussion on what the plans are for the jail property, to ensure any future use is consistent with the needs of Somerville.

As our Board of Health partner, we need to get the County mental health and addiction services to the people on the street who need this help the most.

Somerville is downtown Somerset County, and our successful downtown needs a cultural and performing arts center and theater, and the County needs to have their name on it.

When one thinks of Recreation services, they typically think of children. While that is a core focus of Somerville's recreation programming and facilities, the larger aspect should be inclusive of everyone.

It is time to revisit the Recreation master plan so we can evaluate our facilities, programming, and overall direction that will center on budgeting for facilities, management, as well as obtaining potential grant funding.

I will also establish a seniors and veterans committee out of the recreation department to focus specifically for the needs of these two groups. We will return the Memorial Day Parade to the streets of Somerville, showing true honor to all those who have served our country.

Many of the quality- of-life issues that our residents are frustrated with center on aspects of safety. Pedestrian safety, traffic speed, increased homeless issues, rise in graffiti, condition of our parks and trails, and the list goes on. These different issues require different solutions, but all relate to a safer and better community for all of Somerville. The Pedestrian Safety committee was dissolved a few years ago, I will re-establish a Public Safety committee to take up specific issues the Borough Council refers to them for vetting, and recommending potential solutions.

The single most important job of an elected official is the safety and security of our citizens. We have a fantastic police force led by Chief Manning that is well trained, friendly, fair, firm and consistent in all they do, they are really good. I jog all over town at all hours, and I can tell you I see them everywhere—they can probably say the same about me!

Regardless of why, our police officers have been without a contract for over a year, and that is unacceptable. This will be resolved with a mutual understanding and agreement...we will craft a contract, together, that recognizes the challenges and increased responsibilities our officers face on a daily basis, always with the Somerville taxpayer in mind.

I will work with the New Jersey Department of Transportation to increase pedestrian safety for our children at the crossing at Vanderveer School. Route 28 is a state highway, and Somerville is a walking district, our children are within inches of vehicles as they try to cross the street every day. It's time the State step up and put road and sidewalk improvements in to ensure their safety.

A retail cannabis store has already been approved for the corner of Gaston Avenue and Rt 22. As I see it, the impact of retail cannabis will potentially be seen most in our children, and in our emergency services. As a result, I will ask the council to dedicate the tax revenue from this store specifically towards recreation to give our kids safe and healthy options; and to police, fire, and rescue squad technology and training, so they can operate in a safer manner so they can all go home at the end of the day.

While brick and mortar are necessary for our emergency services, the daily support of the Mayor and council is the most important. This is what keeps our volunteers responding. We are blessed to have the best in firefighters, and Rescue Squad personnel. I have worked with many Chiefs in both areas over the years, and can honestly say each one has taught me a little bit about this town, and the volunteers that serve her. Our volunteer emergency service personnel are some of the greatest assets we have as a Borough...they are our family, friends, and neighbors. Our job as elected officials is to understand their needs and to support them.

Over the years, Somerville has crafted an incredible, wonderful story of how opportunity is created from the challenges we face. How optimism and a sense of 'we can' is paramount. The test of good government is not in how we react immediately to the challenges we face, but how we move forward from them, long term. Our charge as leaders is to preserve and protect the great spirit we have in Somerville, to nurture it for future generations. We must lead forward with that conviction of purpose.

The task ahead is bold. I look forward to working with Borough Council members to meet this commitment with energy, creativity, cooperation, and dedication. Our promise today is that our 2.5 square miles of awesome has only just begun! Thank you.....God Bless our Somerville, and God Bless the greatest nation on earth...The United States of America!
