SUPPORTING SENATE NO. 725 CONCERNING UNLAWFUL OCCUPANCY OF DWELLINGS AND SUPPLEMENTING TITLE 2C OF THE NEW JERSEY STATUTES OF THE STATE OF NEW JERSEY

WHEREAS, the occupancy of a dwelling without the permission of the property owner, also known as "squatting" is an increasing occurrence throughout the State of New Jersey and the Country, Somerville Borough has had several instances that have resulted in significant costs to the local taxpayer; and

WHEREAS, persons engaging in squatting often do so with the express intention of depriving the lawful property owners of the use and possession of their own property for as long as possible, with the express knowledge that squatting is not a criminal offense, thus requiring a property owner to undertake expensive, time-consuming civil litigation to recover their property, which said litigation can be subject to delay tactics including, but not limited to, bankruptcy applications, resulting in squatters successfully depriving lawful owners of the use and benefit of their own property for extended periods of time; and

WHEREAS, Senators Steinhardt, Testa and Polistina have introduced and are sponsoring Senate No. 725, which said legislation would establish squatting in various contexts as criminal offenses and crimes of the fourth degree, thus permitting property owners to avail themselves of filing criminal complaints with local law enforcement that can be duly investigated, and, when appropriate, permit police officers to arrest and remove persons found to be engaged in said criminal squatting activities.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Somerville, County of Somerset, State of New Jersey that it hereby adopts this Resolution to memorialize its strong support for Senate No. 725 and certified copies of this Resolution shall be forwarded by the Borough Clerk to the Office of the Governor and Lieutenant Governor, Representatives in the State Legislature, and the New Jersey League of Municipalities.

<u>T Bonner</u> - The Municipal Alliance and Youth Services Commission meeting was canceled this month. The Library Board of Trustees meeting is on April 25 at 6:30 pm and I'll have a report for you at the next meeting.

<u>R. Pitts</u> - Restaurant Week starts this weekend and goes through April 27. This event features dining deals, shopping discounts and special events. The Girls Night Out event is on Thursday, May 16, from 5 to 9 pm.

<u>G. Stravic</u> - The Health Commission will be represented at the Green Fair on April 20. The Rescue Squad is starting a fund drive. You can donate at www.54rescue.org. The squad could use your help. The Annual Clean Up is on Saturday and we're meeting at the high school at 9 am. From 11 am to 2 pm, there will be a Green Fair on Division Street. We have many requests for street trees and people may have to wait until fall or next year, if we secure additional funding. We will be planting over 140 trees in the next 2 weeks through a grant received from the state. We will be replacing old trees that went down along the brook. The Community Garden committee expanded the garden with 4 more beds. They have 40 applications for 16 garden beds and there will be a lottery. We look forward to the expansion of that program. This past Saturday, Somerville hosted the NJ Environmental Commission workshops and included people from all over the state. This is a very busy time for the Environmental Commission.

<u>T. Mitchell</u> - Last week, 6 classes of second graders from VanDerveer School visited the Fire Museum.

<u>R. Vroom</u> - The Fire Department walked through the new Emergency Services Facility on Gaston Avenue. We know there are going to be growing pains for the Fire and Police departments. The Fire Department is continuing with training their members on state regulations.

PRESENTATION

Sean O'Neill, Life Scout in BSA Troop 83 - John Schaub Park

<u>Mayor Gallagher</u> – We have a presentation from an active Life Scout who is on a quest for his Eagle Scout.

- <u>S. O'Neill My</u> project will be at John Schaub Park on Cliff Street, next to the apartment buildings. Our troop has a lot of our meetings there in the summer. It was recently destroyed during Ida and we haven't really been able to go there.
- <u>S. O'Neill</u> provided the borough council with pictures of the park. John Schaub is important to our troop and we want to honor him with this project. I'm going to be digging up all the weeds and putting new sands between the paver stones, plus shrubbery around the flag. The bushes will survive and thrive in the floodplain. I'm also going to install a flag and a solar-powered light. I'm also going to add 2 Adirondack chairs.

<u>Mayor Gallagher</u> – The idea of Adirondack chairs there is very creative and is a very nice look for that part of the park. It's a great project and we wish you success.

<u>T. Mitchell</u> - John Shaub was scoutmaster of Troop 83 for 47 years and he served the community for over 50 years.

DISCUSSION

<u>Mayor Gallagher - We received a request from the Historic Advisory Committee to create an ordinance authorizing the committee as a standing committee of the borough.</u>

<u>T Mitchell - I</u> only recently found out that it wasn't a standing committee. It has been reestablished every year and they do excellent work for the town. We have a member of the committee here who may want to speak.

<u>Jim Somerville, Bridgewater-</u> The Historic Advisory Committee is instrumental in keeping the history of Somerville alive.

Public Comments

Celine Greaves, Somerville - I have a couple of questions.

<u>Mayor Gallagher</u> - This is a public comment period. There is no Q&A. This is an ability for the public to comment on the policies of the governing body.

<u>Celine Greaves</u> - I would like to point out that there has not been public mention at meetings that there are multiple appeals about the gun store. My understanding is that Mr. John Muselli has left and there has not been any mention of who is going to be the new zoning officer or acting in that capacity. There is not a standard or clear procedure on the borough website for making appeals available to residents who ask for that information. There are regulations, but the paperwork does not exist to make those appeals. There is no transparency for people to be able to do that. Also, there was a tremendous haste to open this particular gun store.

Megan Andrews, Somerville - It appears the rules of order change on a whim at these council meetings. I have witnessed questions and answers and back and forth sometimes. I believe my neighbor who just spoke had reason to believe that answers could be provided. Since December of 2023, all we were told is that nothing can be done. We were never told there is an appeal process. I was really disappointed in that. There are residents who want to be here and want to put their name on the lawsuit, but are afraid because of who we're up against - people with guns. None of this is about people with guns. It's about the specific location of the store.

In regards to the minutes, Mr. Sluka should not have to run tech while doing his job here. Can we get an intern? We've only had 1 set of minutes published since January 16. The February 5 and 20 minutes aren't published. I don't know how you can expect residents to stay involved and know what's going on when the meetings don't always have sound, don't always have video, and then we don't even have minutes.

I was very glad to see the no stopping and standing sign between the entrance and exit on William Street has been put back up there. However, there used to be an exit sign at

the opening to the lot. That sign came down during Covid, but it's still narrow and it should not be an entrance and an exit. This needs to be looked at.

<u>Dan Papuga, Somerville - At the middle school on Davenport Street, during drop-off, people are heading northbound and they're stopping and letting kids out and cars are going around them. I've seen my road turn into 2 lanes northbound with 10 cars backed up at the intersection. That's a problem.</u>

We need to have Davenport, between Cliff and High Street, made into residential parking only. Ten years ago, someone dropped a church on us and we were basically prisoners in our house and now we're starting with the farmer's market on Saturdays. It's going to be the same problem. I came home a couple of weeks ago with 10 bags of mulch and I had to park a block away. Something has to be done.

<u>Mayor Gallagher</u> - Davenport Street is a problem. I do understand the farmer's market may create an impact and that's something we have to monitor. We have a pedestrian safety committee being formed and I'm going to put this on the list of things for them to tackle.

The transparency that this governing body has is extreme. I believe in over customer service and that means bending over backwards for the public. Sometimes when folks get the answers they don't like, they feel they're not getting the answers that they should.

This governing body and the planning board were delayed by about 1.5 months. The delays were due to a civil action being filed in court. Mr. Sluka has bent over backwards trying to provide information. He works extremely hard and he does his job very well. He is stretched thin at times because right now we're being faced with an onslaught of OPRA requests, which is fine. We'll comply with all those OPRA requests. We're actually hiring someone and one of their duties will be to help comply with those OPRA requests. We do try to be completely transparent and will continue to do so.

In terms of the minutes, Mr. Sluka just explained we had some technology hiccups. It's frustrating for me as well. We were in the old space for about 40 years and the pattern has now changed. The tech folks were here for about 1 hour before this meeting and you can tell we're still having issues. We have been very thorough in our ability to get the minutes done on a timely basis and that will continue.

I've been doing this for over 20 years and the rules of order have not changed. Anybody can come up and make any statement they want, but it is a comment period. It is not a period to engage in back and forth. It's a little disheartening when you have people who volunteer their time to make this town the best it can be and we now have folks castigating the people in these positions. I have a problem with folks coming after the employees at Borough Hall, the council members, planning board and zoning board members. And on social media, when they start coming after your families. I have a big problem with that. I ask everyone to take a step back. All of those boards and all of Borough Hall are trying to do the best we can.
