- The first floor had a partial collapse into the basement, as well as the second and third floors. This eventually turned into a 4-alarm fire.
- Approximately 17 fire department agencies and 120 fire personnel responded.
- This fire is still under investigation.
- A total of 5 businesses were disrupted and 18 apartments.

Mayor Gallagher - This was a well-coordinated response. Every resident got out safely. Multiple families and residents were affected by this fire. The Somerville Civic League did an incredible job and ensured these folks were cared for over 5 or 6 days. I was on the phone with Governor Murphy multiple times over the next few days. I told him we needed state troopers to help us close Main Street.

Marco - therapy dog

Officer Nicole DeBiase - I put this program together recognizing all the stress our officers face on a day-to-day basis, as well as members of the community. We're getting a lot of calls for mental health. Thank you to everybody who made this happen. He is a therapy dog and there is a lot of training required, but it's worth it.
