ORDINANCE #2685-22-1003

AMENDING CHAPTER 166-44 SCHEDULE III ENTITLED NO STOPPING OR STANDING TO INLCUDE SECTIONS OF MOUNTAIN AVENUE ON EAST SIDE OF MOUNTAIN AVENUE

WHEREAS, the Borough of Somerville desires to amend Chapter 166, Section 44 Schedule III entitled No Stopping and Standing to read as follows:

§ 166-44 Schedule III: No Stopping or Standing.

In accordance with the provisions of § **166-8**, no person shall stop or stand a vehicle between the times specified upon any of the following described streets or parts of streets:

This ordinance shall take effect immediately upon its final passage and publication as required by law.

ORDINANCE #2680-22-0906

AMENDING THE SOMERVILLE BOROUGH LAND USE LAW TO INCLUDE CHAPTER 102 SECTION 120(K) APPROVING COTTAGE FOOD OPERATION

WHEREAS, the Borough of Somerville amends the Somerville Borough Land Use Law to include Chapter 102 Section 120(K) permitting Cottage Food Operation as an accessory use in all zone districts that allow residences subject to the following requirements:

- 1. There shall be only one such use in any dwelling unit.
- 2. The use shall be operated by or shall employ in the dwelling unit only a resident or residents who are permanent full-time residents of the dwelling unit, and no other persons.
- 3. The use shall be located only within the principal building, and not within any accessory buildings. There shall not be permitted the conversion of garage parking areas to cottage food use.
- 4. The dwelling unit shall not be divided or partitioned in any way to prevent free access between all portions of the dwelling unit and the area devoted to the cottage food use.

- 5. There shall be no change to the exterior of buildings or other structures for the use, and no outside appearance of a business use, including but not limited to parking, storage, signs, or lights.
- 6. The use shall not operate any equipment or conduct any process that creates noise, vibration, glare, fumes, odors or electrical or electronic interference, including interference with telephone, radio, or television reception, any of the foregoing which are detectable by neighboring residents.
- 7. The use shall not require any increased or enhanced electrical, water, natural gas or other utility service, supply, or usage, above what is typically required for residential use in the zone district.
- 8. The quantity and type of solid waste disposal shall be the same as for other residential uses in the zone district.
- 9. The capacity and quality of effluent shall be the same as is typical of normal residential use in the zone district and shall create no potential or actual detriment to the sanitary sewer system or its components.
- 10. Deliveries to and from the use shall be made by the same types of trucks used by the U.S. Postal Service, United Parcel Service, Federal Express and other similar delivery services when providing regular service to residential uses in the zone district (e.g. no larger than a box truck).
- 11. All vehicular traffic to and from the cottage food use shall be limited in volume, type, and frequency to that which is normally associated with other residential uses in the zone district.
- 12. Such uses shall have a Cottage Food Operator Permit issued by the NJ Department of Health and is exempt from the requirement to obtain either a zoning permit or site plan approval.
- 13. Upon request, the resident shall allow inspection of the dwelling by the Borough.

CONFIRMING THE SALE OF \$4,570,000 GENERAL OBLIGATION BONDS, SERIES 2022 OF THE BOROUGH OF SOMERVILLE, IN THE COUNTY OF SOMERSET, NEW JERSEY TO THE SOMERSET COUNTY IMPROVEMENT AUTHORITY

WHEREAS, pursuant to the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, the Borough adopted a resolution on August 1, 2022 (the "Authorization Resolution"), providing for the issuance and sale of bonds to The Somerset County Improvement Authority (the "Authority") in an aggregate amount not to exceed \$5,200,000 to be issued as one series designated as General Obligation Bonds, Series 2022 (collectively, the "Bonds"); and

WHEREAS, pursuant to the Authorization Resolution, the terms of the Bonds shall be confirmed by the provisions set forth herein (the "Confirming Resolution").

NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH OF SOMERVILLE, IN THE COUNTY OF SOMERSET, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) that:

SECTION 1. <u>Ordinances</u>. There shall be issued bonds of the Borough in the following principal amounts pursuant to the following bond ordinances:

A. \$4,570,000 bonds, being a portion of the bonds authorized by an ordinance entitled: (Ord. No. 2675):

"BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$5,200,000 FOR STATION ROAD EXTENSION TO ROUTE 206 IN AND BY THE BOROUGH OF SOMERVILLE, IN THE COUNTY OF SOMERSET, NEW JERSEY AND AUTHORIZING THE ISSUANCE OF \$5,200,000 BONDS OR NOTES OF THE BOROUGH FOR FINANCING PART OF THE APPROPRIATION."

heretofore finally adopted. The average period of usefulness is 20 years.

SECTION 2. <u>Amount of Bonds</u>. The Bonds in the principal amount of \$4,570,000 are hereby issued and sold in accordance with the provisions of the Authorization Resolution and the provisions of this Confirming Resolution. The Bonds shall constitute and shall be designated "General Obligation Bonds, Series 2022".

SECTION 3. <u>Average Useful Life</u>. It is hereby found, determined and declared ,that the average period of usefulness of the improvements or purposes for which the said General Obligation Bonds, Series 2022 are to be issued, taking into consideration the amount of such General Obligation Bonds, Series 2022 to be issued for said improvements or purposes, is 20 years.

SECTION 4. Description of the Bonds.

(a) <u>Terms of the Bonds</u>. The Bonds shall be dated and shall bear interest from the date of delivery at the rates, and shall mature, subject to prepayment as herein provided, on September 1 in the year and in the principal amount set opposite such year in the following table:

(b) <u>Form of the Bonds</u>. The Bonds shall be in substantially the form set forth in the Authorization Resolution, which form is by this reference incorporated in full as if set forth herein, with such omissions, insertions and variations as are properly required and which are not contrary to any of the provisions of the Authorization Resolution or any of the provisions of this Confirming Resolution.

SECTION 5. Redemption of the Bonds.

The Bonds maturing on or before September 1, 2032 shall not be subject to redemption prior to their respective maturity dates. The Bonds maturing on or after September 1, 2033 shall be subject to redemption prior to their respective maturity dates, on or after September 1, 2032 at the option of the Borough, upon notice as described in a bond resolution adopted by the Somerset County Improvement Authority on August 11, 2022, either in whole or in part by lot within a single maturity from maturities selected by the Borough, on any date, at a redemption price equal to 100% of the principal amount thereof (the "Redemption Price"), plus in each case accrued interest to the date fixed for redemption.

If notice of redemption has been given as provided herein, the Bonds or the portion thereof called for redemption shall be due and payable on the date fixed for redemption at the Redemption Price, together with accrued interest to the date fixed for redemption.

SECTION 6. <u>Award of the Bonds</u>. The Bonds are authorized to be sold and awarded to The Somerset County Improvement Authority (the "Authority") at a purchase price of \$5,070,666.20 for the Bonds. The terms and conditions of such offer are set

forth in a bond purchase agreement, dated September 22, 2022 (the "Bond Purchase Agreement"), a copy of which is attached hereto as <u>Exhibit A</u> and which by this reference is made a part hereof as if set forth in full herein. Settlement for the Bonds was made in immediately available funds on September 29, 2022.

SECTION 7. <u>Additional Acts</u>. On behalf of the Borough, the appropriate representatives of the Borough are authorized and directed to take all steps which are necessary or convenient to effectuate the terms of the Authorization Resolution and the terms of this Confirming Resolution with respect to the issuance, sale and delivery of the Bonds.

SECTION 8. <u>Effective Date</u>. This Confirming Resolution shall take effect upon adoption hereof.

DEPARTMENTAL REPORTS & NOTICES

The mayor said there were no reports or notices.

COMMITTEE REPORTS

<u>T. Mitchell -</u> Weekend Journey Through the Past will be held on Oct. 8 and Oct. 9. On Sunday, Oct. 9 at 1 pm, there will be a ceremony to plant the historic Salem Oak seedling. The Diversity Festival is on Oct. 16, the Ghost Walk on Oct. 23, Stories, Myths & Legends on Oct. 29 and the Native American Heritage Celebration on Nov. 15. On Oct. 13, we will be breaking ground on the Emergency Services Facility. Habitat for Humanity is building an affordable house on Grove Street for a low-income veteran. There will be a meeting about the potential sewer system sale on Wednesday Oct. 5 at the library.

To clarify comments from last week, our PILOT agreements with developers are not sweetheart deals. We have a pay-to-play ordinance to ensure that. The Redevelopment Committee, working with our consultants, determines the parameters to maximize revenue to the Borough. This revenue is being used to fund the construction of our much-needed Emergency Services Building and to stabilize taxes.

R. Vroom - Thank you to the first responders who responded to the fire last week. October is fire prevention month. New guidelines recommend smoke detectors in every room and sleeping with the bedroom door closed. Check your smoke detectors every 6 months. Please also check fire extinguishers. They have a shelf life of 10 years. Reach out to the fire marshal or bring expired fire extinguishers to a firehouse to be used for training. From the inception of a fire, you have about 3 minutes to vacate the premises. Make sure little ones know how to get out.

<u>G. Brady - A website has been set up with information about the sewer sale referendum.</u> There was a public meeting on Thursday at the American Legion to present facts about the referendum. The sewer system is underground, and we don't know what's going to fail next. NJ American Water has the resources to evaluate and maintain the system.

<u>G. Stravic - The Environmental Commission had their annual training last week. The Salem Oak tree planting ceremony at the Wallace House is being coordinated by the Environmental Commission, in coordination with the curator. The Environmental Commission encourages everyone to compost their leaves and garden materials.</u>

<u>F. Wied - The Finance Committee is working with departments to plan for future spending.</u>

<u>Mary Stack, 47 S. Adamsville Rd - Expressed concern about demolition of the Baker and Taylor building, which is adjacent to her property. Asked if the borough can ask the builder to get an exterminator to prevent any rodent issues.</u>

She also said she lives on a block where trucks over 4 tons are allowed to turn around, this is now an industrial area. The trucks run all day and night and sometimes block her

driveway. Asked if there is a way to divert the traffic. Also expressed concerns about trucks idling for hours.

K Sluka - The demolition permit was just issued, and baiting is required.

Mayor Sullivan – I discussed this with the planner in Bridgewater and she is researching the uses on the Bridgewater side. There has been a change in ownership. I also spoke with the previous mayor about this situation. The police can address the concern about trucks idling. I'm waiting to hear back from the planner about what the approved uses are and if there are any truck restrictions.

<u>George Ogletree, 7 W Spring St</u> - Grew up in the south side and it was the best experience. Fifty years later, my family members can't afford to live here anymore. The rent in the new apartment buildings is too high. Urged the council members to help the people who want to stay in Somerville.

<u>Howard Bell, Branchburg</u> - People need someone to fight for affordable housing. People are getting pushed out of Somerville by high rent prices. The town should be affordable for seniors.

<u>Geraldine Freeman, Somerville -</u> Criticized the high rent prices and condition of the roads. Main Street looks good, but this is not a place where everyone is happy about where they live. People are angry. White people are buying property on 3rd Street and pushing black people out. We should all be working together.

<u>Brian Gallagher, Somerville</u> - Suggested contacting Mike Coyle about creating an exit going out to Finderne.

Mateo Garcia, 171 Mercer St - There is a business owner in downtown Main Street who rents in the Brookside Garden Apartments who has complained that his rent has gone up by \$400 in one year. The high rent prices are a serious issue. What is happening in Somerville is gentrification, as more affluent white people are displacing black and brown people in town. These are the folks that are leaving. Despite numerous complaints, I haven't seen any formal action being taken to address this issue.
