#### **COMMITTEE REPORTS**

<u>R. Vroom</u> - A reminder to have boilers and hot water heaters checked out and make sure all is running properly. Also, make sure you have a carbon monoxide detector near any heating apparatus. Also, leading up to the holidays, don't leave flames unattended and check batteries in smoke detectors.

- <u>G. Brady</u> Over 74% of Somerville residents voted to sell the sewer system to NJ American Water. We anticipate closing in 2023. The budget meetings are moving along. The state has not yet provided us with actual costs of health benefits. There will be an increase that will be paid from our taxes.
- <u>G. Stravic</u> New trees were planted in Lepp Park and the community garden is ongoing. Both were spearheaded by the Environmental Commission. The Facebook page is a source for public education.
- <u>F. Wied</u> In the new year, the Youth Services and Municipal Alliance Committee is offering Narcan training to the public. This will help anyone who overdoses on opioids. The Turkey Trot is this Thursday. We're always looking for volunteers.

R. Pitts - The Downtown Somerville Alliance is gearing up for the holiday season, kicking off with the annual Small Business Saturday event. Friday, Dec. 2 is the annual Holiday Jubilee when we light the tree and welcome Santa Claus. Ice skating on Main Street will be new this year. The DSA is working with Arterial Streets to update our downtown streetscape and put together a capital plan for a complete overhaul.

Four of our police officers were recognized at the NJ PBA Valor Awards Ceremony: Officers Kevin Gilbert, Michael Sergi and Alex Lora and Sgt. Tim Pasquale.

<u>Mayor Sullivan</u> - The Courier News recognized 191 businesses as the Best of the Best and 26 of the award winners were from Somerville.

### **DISCUSSION**

#### **Best Practices**

<u>K. Sluka - The state of NJ started a program about 7 years ago that requires every municipality that receives aid or revenue from the state to review a survey. We have to score a minimum of 24 points. A score lower than 24 would lead to a reduction in revenue. We scored 33 points this year. Addressing lead remediation is a new issue. Procurement ethics is also an important area. We will post the results on the website.</u>

# **Affordable Housing- Next steps**

<u>Mayor Sullivan -</u> Moving forward into 2023, it's important for the Borough Council and the Planning Board to work together on affordable housing.

<u>K. Sluka -</u> The idea is to ask the Planning Board into looking at possible set-asides. If there isn't a conflict, the Planning Board could engage Kyle McManus Associates to serve as their expert, look at the master plan and see if there's an opportunity to create a set-aside. Then, the Planning Board could bring a set-aside ordinance back to the Council for consideration. I think we need someone with significant experience to guide you on this.

<u>Mayor Sullivan</u> - We want to do it right and involve people who have expertise. I like the idea of interacting with the Planning Board.

- <u>G. Brady</u> We would need a resolution to hire Kyle McManus Associates to work with the Planning Board to build an affordable housing plan. This is a first step towards building a framework for someone who would want to build homes in town that are a bit more affordable.
- <u>G. Stravic -</u> I'm very much in favor of looking at affordable housing. I don't think just a set-aside is enough. I think we need to look at other options for affordable housing and maybe this expert can advise us on that as well.
- <u>F. Wied This is a good start and long overdue.</u> Half of Somerville are renters and it's important that we look out for the renters too because we're all residents. We want to keep the renters in town too.
- <u>R. Vroom</u> It's important that we utilize our experts and that we get the right information. We have to make sure that we're thorough in our process. Everyone wants a quick turnaround on this, but the last thing we want is to put something forth and have it be contestable. This is a good start, and if we can, I look forward to working with the firm.
- R. Pitts I'm looking forward to moving this ahead.
- <u>J. Solomon The first step is to find out if there's a conflict.</u>

<u>Anthony Park, 49 3rd Street</u> - Asked about permit parking and how this will affect his relatives who visit from out-of-town.

<u>K. Sluka</u> - Each of the vehicles registered at a location gets a parking permit. An additional 2 guest hang tags are provided. A letter went out to the residents and another letter will be sent. It's likely enforcement will start after the new year, so that gives people a month to get the passes. You can do this online.

<u>Geraldine Freeman - I</u> know things move slow, but this (affordable housing) has been very slow. There isn't any affordable housing with all the buildings that are currently being built. This should have been done a long time ago. You're trying to push people out of Somerville. I can't even afford to live here. It's ridiculous that you have to wait this long to get affordable housing. Get it together because there are a lot of people that are affected by this.

Mateo Garcia, 139 Mercer St - I applaud the council for continuing the conversation on affordable housing. This is an issue that long predates this current governing body. I understand there's some timidity to moving forward under the guise of good governance, but we must act swiftly. The speaker (at the previous meeting) presented other options for creative solutions, which should be considered. How many of the current developments being built now have affordable housing and how many of the new developments that will be built have affordable housing? I believe the number may be zero.

<u>Troop 84</u> - 3 Boy Scouts responded to Mayor Sullivan's invitation to guess how much money it takes to run the town.

F. Wied - The borough budget is about \$29 million. The school budget is separate.
