REMOVING ARTICLE XIII ENTITLED STREET CLEANING CHAPTER 166-31 NO PARKING FOR STREET CLEANING AND REMOVING 166-62 SCHEDULE XXI ENTITLED NO PARKING FOR STREET CLEANING TO ELIMINATING STREET CLEANING ENFORCEMENT THROUGHOUT THE MUNICIPALITY

WHEREAS, the Borough of Somerville desires to remove street cleaning enforcement regulations; and

WHEREAS, the street cleaning operations will occur in order to meet both storm water regulations and to provide for clean streets; and

WHEREAS, the Borough of Somerville desires to remove Chapter 166 Section 31 entitled No Parking for Street Cleaning from the Borough Code; and

WHEREAS, the Borough of Somerville desires to remove Chapter 166 Section 62 Schedule XXI entitled No parking for street cleaning from the Borough Code.

WHEREAS, upon passage of said ordinance signs shall be removed indicating "no parking" as per Schedule XXI

ARTICLE XIII Street Cleaning

166-31. No Parking for Street Cleaning

No person shall park a vehicle between the hours of 9:00 a.m. and 1:00 p.m. on the days specified upon any street or parts of street described in Schedule XXI from March 1st through October 31. All street cleaning regulations are suspended in the months of November, December, January and February.

AUTHORIZING MEMORANDUM OF AGREEMENT TO BE DRAFTED BETWEEN THE BOROUGH OF SOMERVILLE AND THE SOMERVILLE FIRST AID AND RESCUE SQUAD FOR USE OF 137 WEST HIGH STREET, BLOCK 115, LOT 6

WHEREAS, the Borough of Somerville is the owner of 137 West High Street, Block 115, Lot 6, commonly referred to as the West End Hose Company #3; and

WHEREAS, the West End Hose Company #3 is an active firehouse providing emergency response services to the residents of Somerville Borough and mutual aid response; and

WHEREAS, the Borough of Somerville has entered into a Redevelopment Agreement with FD Stonewater to construct an Emergency Services Facility on North Gaston Avenue, Somerville; and

WHEREAS, the 137 West High Street was placed into the West End Redevelopment Area; and

WHEREAS, the West End Hose Company #3 is expected to relocate into the Emergency Services Facility on North Gaston Avenue; and

WHEREAS, once the West End Hose Company #3 fully relocates to the Emergency Services facility on North Gaston Avenue the firehouse at 137 West High Street shall be vacant; and

WHEREAS, the Borough of Somerville has identified several needs for the facility at 137 West High Street; and

WHEREAS, the Mayor and Council of the Borough of Somerville recognizes the Somerville First Aid and Rescue Squad has expressed an interest in the use of 137 West High Street; and

WHEREAS, the Mayor and Council has determined that the use of 137 West High Street by the Somerville First Aid and Rescue Squad would be an appropriate and beneficial use for the residents of Somerville Borough; and

WHEREAS, the Mayor and Council directs legal counsel to prepare a Memorandum of Understanding that would provide for a termed agreement identifying Somerville First Aid and Rescue Squad as a leasee that would cover all daily maintenance, utilities, including telephone, cable, electric, sewer and water, renovations required for their operations, insurance and all other customary costs related to a leasee; and

WHEREAS, after agreement by both parties the Mayor and Council shall approve the Memorandum of Understanding by resolution and said resolution shall remain in effect until said building is vacant; and

WHEREAS, as required by law, the Mayor and Council will enter into a formal lease and any other documents deemed necessary by law:

BE IT RESOLVED, by the Borough Council of the Borough of Somerville, in the County of Somerset, State of New Jersey intends to enable 137 West High Street, Somerville New Jersey to be used by the Somerville First Aid Squad and Rescue Squad and directs legal counsel to draft a Memorandum of Understanding for consideration to be executed by both parties.

BE IT FUTRTHER RESOLVED, by the Borough Council that legal counsel shall draft the lease agreement and all other documents necessary for the formal use of 137 West High Street by the Somerville and First Aid rescue Squad.

AFFIRM THE BOROUGH OF SOMERVILLE'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of Borough of Somerville to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of Borough of Somerville has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Borough of Somerville that:

- **Section 1:** No official, employee, appointee or volunteer of the borough by whatever title known, or any entity that is in any way a part of the borough shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the borough's business or using the facilities or property of the Borough of Somerville.
- **Section 2:** The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the borough to provide services that otherwise could be performed by the borough.
- **Section 3:** Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- **Section 4:** The Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

E. Kelleher - The map shows the property backs up against the B-1 area.

<u>G. Brady</u> - I did visit the site. I think this is an excellent opportunity. I have no objections.

<u>F. Wied</u> - Expressed concern about a potential rush of people who may want to appear at future meetings to request minor changes.

<u>K. Sluka</u> - That is a governing body responsibility. In 15 years, there have been a couple of applications before the Council.

<u>Mayor Sullivan</u> - Every application we would hear on a zoning change has to stand on its own merit. I like it and it seems simple.

<u>J. Solomon</u> - The Council is not taking any formal action tonight. The next step is a Planning Board application.
