ORDINANCE #2721-24-0116

AMENDING CHAPTER 6 OF THE BOROUGH CODE ENTITLED MARRIAGE AND CIVIL UNION CEREMONY FEES

BE IT ORDAINED THAT Chapter 6 of the Borough Code entitled Marriage and Civil Union Ceremony Fees shall be amended to read as follows:

§ 6-1 Purpose.

The purpose of this chapter is to establish policies and procedures for the collection of fees associated with the performance of marriage and civil union ceremonies performed by the Mayor.

§ 6-2 Collection of Fees; Compensation through the Performance of Marriage and Civil Union Ceremonies.

- A. Collection of fees. Persons seeking to be married or joined in civil union ceremonies by the Mayor shall remit the appropriate fee to be paid to the Borough of Somerville.
- (1) Fee for officiant in the amount of \$250
- (2) Administrative Fee of \$35.00
- B. Compensation through the performance of marriage and civil union ceremonies.
- (1) Receipt of fees. The fee shall be paid by check to the Borough of Somerville and shall be deposited in the Borough's current fund.
- (2) Disbursement of fees. The fee for service in the amount of two hundred fifty dollars (\$250) may be disbursed to the Mayor in the amount of two hundred fifty dollars (\$250) through the appropriate budget line item and with the appropriate authorization.
- (3) The Mayor may waive the officiant fee but shall not waive the administrative fee.

ESTABLISHING CHAPTER 103 OF THE BOROUGH CODE ENTITLED LEGALIZED GAMING

Chapter 103 Legalized Gaming

Article I **Legalized Gaming and Fees**

§ 103-1 Legalized games defined.

Licenses issued for Raffles, Bingo, and Casino Nights by the Borough Clerk in accordance with the rules and regulations and approval issued by the State of New Jersey Legalized Games of Chance Commission (LGCCC). Legalized games of chance include off-premises draw raffles for merchandise, off-premises 50/50 cash raffles, on-premise 50/50, non-draw raffles, on-premise draw casino night, bingo, armchair races, tab pulls and any other games of chance authorized by the State of New Jersey Legalized Games of Chance Control Commission.

§ 103-2 Days allowed to conduct legalized games of chance.

Approved and legalized games of chance are able to be conducted on any day of the week.

§ 103-3 Forms and application.

All forms are available on the State of New Jersey Legalized Games of Chance Control Commission website.

§ 103-4 Fees.

The Borough Clerk shall charge a fee that is equal to the fee that is charged by the State of New Jersey Legalized Games of Chance Control Commission.

- A. The applicant shall submit two checks one payable to the Borough of Somerville and one payable to Legalized Games of Chance Control Commission.
- B. With certain raffles additional fees are required by the State of New Jersey Legalized Games of Chance Control Commission. In those cases, the Borough shall also receive an amount payable to the Borough of Somerville.
- C. Payment of Fees is only payable by check or money order and the applicant shall not combine checks.

WHEREAS, the Redeveloper entered into a contract with David E. Harvey Builders, Inc. (the "Contractor") dated June 2, 2022 (the "Construction Contract") providing for the construction of the Project on the Property by Contractor; and

WHEREAS, the Borough of Somerville Volunteer Fire Department (the "SFD") had previously committed to supply their current apparatus exhaust extraction system(s) to the new Project; and

WHEREAS, upon detailed evaluation of the current system(s) that were to be provided by SFD for the Project, the SFD has determined that the current installed apparatus exhaust extraction systems in the various firehouses are not in a condition to be reused in the new Project; and

WHEREAS, the SFD had originally in 2022 identified the Cleanair Company Plymovent system as the system to be installed in the new Project; and

WHEREAS, on reexamination of available apparatus exhaust systems, the SFD has determined that the Nederman System is best suited for the needs of the SFD when the commence occupying and using the new emergency services facility; and

Public Comments

<u>Michelle F</u> - I'm here to advocate against the gun and ammo shop intending to open under the sporting goods permit at 131 Gaston Avenue. I don't think it's a radical idea to object to an arsenal of weapons located so closely to our students. These types of stores lead to increase in crime and a drop in property values.

<u>Caroline F.</u>I wonder what this will do to the property values in that area of Somerville. I ask the council and zoning board to consider banning weapon sales within 1 mile of a school. Piscataway has a similar ordinance and was more proactive than us. I didn't think this was a possibility when moving into Somerville.

<u>Elizabeth Shore</u> - It takes an immense responsibility to be a gun owner. I would appreciate it if there's anything we can do to take the signage back so it doesn't look like a gaming store. It sends our children a mixed message.

Megan Andrews - I support all the previous comments. I have 20 years of experience as a public school teacher in NJ. It's hard to find information online about this store.

<u>Emily K</u> - I'm encouraged by your words about looking at the zoning laws. What are the rules about kids going into this store? Is that even legal for a kid? I want to see the police involved because these stores are a magnet for crime. We need to proactively make sure this store is complying with all applicable laws.

<u>Kate A</u> - Our children do not need to be exposed and desensitized to weapons and ammunition simply by walking home from school. Opening a gun shop in our neighborhood does not reflect the values of our community. I ask that you ensure this can't happen again in the future.

Resident, 63 West Orchard Street - There are many more residents who feel this same way and are not here to say it. You all have an opportunity to make Somerville safer and keep it the town we've all come to love.

<u>Christina Eddleman</u> - I am a teacher in our middle school here in Somerville. Our school district is a walking school district. As you look at zoning laws, remember that children walk on every single street on their way to school. It's important for us to see what they're seeing.

Rick Treut - If I were you, I would think creatively about how to stop this thing.

<u>Michiel Meulenberg</u> - I was upset when I found out an ammunition weapons store was opening up about 4 blocks from my house and next to the school. I stand with the residents here. I'm appalled that zoning allows this in proximity to the schools.

<u>Margaret Weinberger</u> - I want to make sure that you are diligent about getting the exact measurements of the distance of the store to the corner property of the school.
