Item 6.1: Discussion, Direction and Possible Action on the Participation in Sonoma County Transit's Fare-Free Program on Route 32 and Approve Resolution Authorizing the City Manager to Execute Agreement for January 1, 2019 through June 30, 2020 (City Manager)

Motion by Council Member Hundley, seconded by Vice Mayor Harrington, to adopt Resolution Declaring a Shelter Crisis Pursuant to SB 850 (Chapter 48, Statutes of 2018, and Government Code 8698.2). Motion carried unanimously.

Item 6.3: Discussion, Consideration, and Possible Action on a Request by the Blue Wing Adobe Trust for \$1 Million from the City of Sonoma to Support Acquisition and Preservation of the Castagnasso Mission Bell Farm (located at 196 East Spain Street) with the Purchase of a Conservation Easement (City Manager)

Action: Council gave direction to staff.

Motion by Council Member Edwards, seconded by Vice Mayor Harrington, to pledge financial support not to exceed \$500,000 to the Blue Wing Adobe Trust for the purpose of purchasing a conservation easement as part of the final escrow payment; to waive processing fees for various city permits for five years from the date of escrow; authorize the City Manager and City Attorney's Office to negotiate terms for a purchase and sale agreement and conservation easement, which would be brought to City Council in December with a resolution for approval to proceed; and to authorize the Mayor to sign a letter of support outlining the City Council's direction and commitment for the BWAT's communication with various funders. Motion carried unanimously.
