4. CONSENT CALENDAR

Motion by Council Member Agrimonti, seconded by Vice Mayor Harvey, to approve the Consent Calendar including Resolution #20-2019 and #21-2019. Motion carried unanimously.

Item 4.1: Adopt a Resolution Authorizing the City Manager to Purchase Two Utility Trucks and One Dump Truck to Replace Existing Vehicles for the Public Works Department (Public Works Director/City Engineer)
Action: Approved as Resolution #20-2019.

Item 4.2: Adopt a Resolution Approving an Application for Temporary Use of City Streets for the 2019 Valley of the Moon Vintage Festival Parade, Blessing of the Grapes, Fire Department Bucket Brigade and Foot Race (September 28th and 29th, 2019) And Request for Fee Waiver for the Parking Fees Associated with the Use of City Streets for 2018 and 2019 (Special Events Manager)
Action: Approved as Resolution #21-2019.

5. PUBLIC HEARING

Item 5.1: Public Hearing: Discussion, Consideration, and Possible Action on an Appeal Filed by the Viviani Trust of the Planning Commission's Action on February 25, 2019, Regarding the 2004 Use Permit as Memorialized by Planning Commission Resolution # 03-2019 (Planning & Community Services Director)
Action: Public Hearing was opened and continued to August 5, 2019.

Motion by Vice Mayor Harvey, seconded by Council Member Cook, to open the public hearing and continue it to June 24, 2019. Motion carried unanimously.

Action: Ordinance was introduced, and the first reading conducted.

Motion carried with Council Member Hundley, Vice Mayor Harvey, and Mayor Harrington voting YES; and Council Member Agrimonti and Council Member Cook voting NO.
