#### (b) Discussion, Consideration, and Possible Action on CASA Compact

 Report on Legislative Committee's Work on CASA Compact and Letter (Chairman Hundley)

Council Member Hundley (Sonoma) gave a report on what actions the Legislative Committee had taken. She presented the Board with a copy of a letter that the committee had prepared and submitted. The key points of the CASA Compact that it addressed were the "one size fits all" approach, the diversion of revenue from Sonoma County, and not being able to obtain data with projections as to what it would cost the County.

Report from Mayors on Actions by Individual City Taken to Date

Mayor Dell'Osso (Cotati) noted that Cotati had put together a letter addressing their concerns. He noted that his biggest concern was the way CASA was moved through MTC and ABAG made it appear that there was

consensus from all of the counties, which was not accurate. He felt that there was a number of legislative bills that appeared to have support that was not actually there.

Mayor Hinton (Sebastopol) stated that Sebastopol would be abstaining from any votes on the item since they did not feel that the Mayors & Council Members Association was vested with the authority to take a legislative position; 2. Sebastopol has already voted on CASA with the League of California Cities Legislative Committee in favor of sending a letter of opposition which all had received; and Sebastopol will take an official position on CASA and submit its own letter in response after CASA is agendized and they have heard from their members of the public.

Mayor Bagby (Cloverdale) stated that Cloverdale was opposed to the CASA Compact in general and would be supporting the letter.

Mayor Hagele (Healdsburg) stated that Healdsburg had officially opposed the CASA Compact. He noted that their biggest issue was related to local control. Mayor Hagele said that they also had discussed the regionalization and local tax dollars going to some big entity and how much would come back to Healdsburg. He stated that they were doing a lot locally.

Mayor Barrett (Petaluma) stated that Petaluma had held a workshop but did not take formal action. Their concerns were also regarding local control and revenue. She noted that there was also some support for the Compact.

Mayor Schwedhelm (Santa Rosa) stated that Santa Rosa had a robust discussion but did not take any formal action either. He noted that their representative on the Legislative Committee had shared the letter with them and he believed that Santa Rosa's strategy was going to be to address the pieces of legislation one by one as they came out.

Mayor Harrington (Sonoma) stated that Sonoma had opposed CASA for many of the reasons already stated. She noted local control, RHNA number status, regional body spending local tax dollars.

Mayor Belforte (Rohnert Park) stated that was difficult for Rohnert Park was that they were building. She said that there was also a transportation crisis which went hand in hand with housing. Their biggest concern was the process and how it unfolded. She spoke about lobbyists, upcoming legislation and the need for a united front going forward.

Mayor Foppoli (Windsor) stated that they were dealing with district elections so had not agendized it.

 Discussion by Board of Directors and Possible Action to Take a Position on CASA with Board Recommendation to bring to the General Membership at the June Meeting for Action

Chair Harrington put forward a few courses of action the Board could possibly take: make recommendations to be put forward to the general membership; form a sub-committee to draft a letter for consideration by the general membership in June; or visit Sacramento.

Mayor Dell'Osso (Cotati) felt a letter would be impactful.

Mayor Bagby (Cloverdale) stated that it would be good to encourage individuals to attend the League's Legislative Action Day.

Mayor Hagele (Healdsburg) said he felt that legislators were rushing to introduce bills on housing and did not feel they would be listening. He suggested each city focus on their communities and would be hesitant to spend to much time drafting letters when they could be spending their time doing something locally.

Mayor Belforte (Rohnert Park) expressed concern that if legislators do not hear from the cities, they think it is okay. She thought the county needed to communicate how they felt.

Mayor Bagby (Cloverdale) suggested that the group watch two bills by Senator Weiner and Senator McGuire.

A subcommittee of Mayor Dell'Osso, Mayor Harrington, and Mayor Belforte was formed to draft a letter to be brought back before the general membership in June.

SUBJECT: Request for Item to be brought forward to the Mayors and Councilmembers Executive Board Meeting Agenda at its Meeting of August 2019 (Mayor Hinton, Sebastopol)

According to the By Laws of the Board for the Mayors and Councilmembers Association – the Board reviews policy items and develops the agenda for the Association. (1) In connection with the development of the agenda for the Association, any member of the Board of Directors may, during a regular Membership meeting or Board of Directors meeting, request to place an item on the next Regular Membership Meeting Agenda. The Board of Directors will determine by majority vote of a quorum of the Board whether to place the item on the agenda for the next regular Membership Meeting.

Mayor Hinton, City of Sebastopol, has requested that the Board consider making a formal request to propose to add an alternate position to the current Metropolitan Transportation Commission (MTC) Appointment. In the recent re-appointment of Councilmember Jake Mackenzie for the next four-year term this idea was suggested by two Sonoma County Board of Supervisors. (See letter attached)

Full representation at all times is important for the Metropolitan Transportation Commission appointment. This proposed alternate position would ensure that in cases of absences for whatever reason someone from Sonoma County Mayors' and Councilmembers' could not attend, our member would always present and participating.

#### The Board is being asked tonight to consider the following:

1. To move the recommendation forward to August 2019 MC Executive Board Meeting Agenda in which case the Executive Board will vote to place the item and if approved, would move on the MC General Membership Meeting of October 2019. A full vote by membership would then be taken. If action is approved, then a letter will be sent with recommendation to the Sonoma County Board of Supervisors. This action would support the concept suggested to create an Alternate Seat for the Metropolitan Transportation Commission position held by a Mayors' and Councilmembers' appointment.

Dear Executive Board Members,

As you know, the Board of Supervisors recently reappointed Councilmember Jake Mackenzie to represent Sonoma County on the Metropolitan Transportation Commission (MTC) for the next four-year term.

At the Board of Supervisors meeting on May 14<sup>th</sup>, 2019 I mentioned that I felt it would be in Sonoma County's interest to consider adding an alternate position to the MTC seat as well. Supervisor Gore is interested in exploring this option as well.

We feel this would be important to offer an "apprentice" opportunity that may give some experience for future appointments. Additionally, and possibly more important, the appointed alternate could serve in cases of vacation, illness or conflicts for the current Metropolitan Transportation Commissioner. The new alternate position would ensure that Sonoma County always has full representation at MTC meetings. This is common practice for most committee appointments.

We are aware that Mayor Hinton of Sebastopol plans to bring it to the Executive Board Meeting of Mayors' and Councilmembers' Association in June for discussion and possible recommendation to your full membership.

If your organization is in support of the idea as we are, we encourage you to make a formal request with recommendation back to the Board of Supervisors. With your recommendation, we would then submit the idea to the full board so that we may discuss the concept further and possibly move the request on a State level.
