(b) Report from Sub-Committee (Cotati/Rohnert Park/Sonoma) and Update on Action Item from April 11, 2019 Board Meeting Regarding CASA Compact Letter

Mayor Dell'Osso (Cotati) stated that he had drafted a letter and distributed it to the members of the Sub-Committee. He noted that the timing coincided with SB50 becoming a two-year bill. Upon discussion, the sub-committee felt it would be better to not send the letter or send at a later date.

Mayor Harrington (Sonoma) noted that the sub-committee had consulted with the League of California Cities and received the advice to wait to send the letter.

Mayor Belforte (Rohnert Park) stated that at their Council meeting they had reviewed bills and took a position on them. She noted that they would prepare a letter stating their positions and the reasons why they took them. Mayor Belforte stated that she would share the letter with the group.

Mayor Harrington (Sonoma) noted that it would be a good idea to keep track of the things that are being done by the Cities, so in the future, if it comes up again, there will be record that can be articulated to the legislators.

SUBJECT: Request for Item to be brought forward to the Mayors and Councilmembers Executive Board Meeting Agenda at its Meeting of August 2019 (Mayor Hinton, Sebastopol)

According to the By Laws of the Board for the Mayors and Councilmembers Association – the Board reviews policy items and develops the agenda for the Association. (1) In connection with the development of the agenda for the Association, any member of the Board of Directors may, during a regular Membership meeting or Board of Directors meeting, request to place an item on the next Regular Membership Meeting Agenda. The Board of Directors will determine by majority vote of a quorum of the Board whether to place the item on the agenda for the next regular Membership Meeting.

Mayor Hinton, City of Sebastopol, has requested that the Board consider making a formal request to propose to add an alternate position to the current Metropolitan Transportation Commission (MTC) Appointment. In the recent re-appointment of Councilmember Jake Mackenzie for the next four-year term this idea was suggested by two Sonoma County Board of Supervisors. (See letter attached)

Full representation at all times is important for the Metropolitan Transportation Commission appointment. This proposed alternate position would ensure that in cases of absences for whatever reason someone from Sonoma County Mayors' and Councilmembers' could not attend, our member would always present and participating.

The Board is being asked tonight to consider the following:

1. To move the recommendation forward to August 2019 MC Executive Board Meeting Agenda in which case the Executive Board will vote to place the item and if approved, would move on the MC General Membership Meeting of October 2019. A full vote by membership would then be taken. If action is approved, then a letter will be sent with recommendation to the Sonoma County Board of Supervisors. This action would support the concept suggested to create an Alternate Seat for the Metropolitan Transportation Commission position held by a Mayors' and Councilmembers' appointment.

Re: Alternate Position for Metropolitan Transportation Commission Appointment

Dear Executive Board Members,

As you know, the Board of Supervisors recently reappointed Councilmember Jake Mackenzie to represent Sonoma County on the Metropolitan Transportation Commission (MTC) for the next four-year term.

At the Board of Supervisors meeting on May 14th, 2019 I mentioned that I felt it would be in Sonoma County's interest to consider adding an alternate position to the MTC seat as well. Supervisor Gore is interested in exploring this option as well.

We feel this would be important to offer an "apprentice" opportunity that may give some experience for future appointments. Additionally, and possibly more important, the appointed alternate could serve in cases of vacation, illness or conflicts for the current Metropolitan Transportation Commissioner. The new alternate position would ensure that Sonoma County always has full representation at MTC meetings. This is common practice for most committee appointments.

We are aware that Mayor Hinton of Sebastopol plans to bring it to the Executive Board Meeting of Mayors' and Councilmembers' Association in June for discussion and possible recommendation to your full membership.

If your organization is in support of the idea as we are, we encourage you to make a formal request with recommendation back to the Board of Supervisors. With your recommendation, we would then submit the idea to the full board so that we may discuss the concept further and possibly move the request on a State level.
