### **KINCADE FIRE FACT SHEET : FOR PUBLIC DISTRIBUTION**

October 27, 2019 – 6 AM

- CAL FIRE reports that the Kincade fire has spread to 25,455 acres and is currently 11 percent contained.
- 77 structures have been destroyed, including 31 homes.
- The fire moved quickly overnight CalFire will provide an update at 7am.

### **FIRE WEATHER WATCH**

- The National Weather Service issued a Red Flag Warning for Sonoma County in effect from 8 PM Saturday, Oct 26 to 11 AM, Monday, Oct 28 due to dangerously strong winds.
- Extreme fire conditions are expected with strong north to northeast winds and low humidity through much of Sunday, Oct. 27. Conditions can result in erratic behavior for the Kincade fire . Any new fires have the potential to spread rapidly.

### **EVACUATIONS**

The Mandatory Evacuation Zones have recently been updated. A mandatory evacuation means people should evacuate immediately.

- **Mandatory Evacuation Zones now include:**
  - Zone 1: Geyserville
  - Zone 2: Knights Valley
  - Zone 3: Healdsburg and Windsor
  - Zone 4: Dry Creek Valley
  - Zone 5: Mark West, Larkfield, Wikiup
  - Zone 6: County jurisdiction of Porter Creek, Petrified Forrest, Calistoga and St. Helena Roads
  - Zone 7: Forestville, Guerneville, Duncans Mills, Jenner, Bodega Bay, Occidental
  - Zone 8: Sebastopol and Valley Ford
  - Zone 9: Coffey Park and Santa Rosa north of Guerneville Rd/Steele Lane
  - Zone 10: West of 101 Road between Guerneville Road and Ludwig Avenue

### EVACUATION CENTERS

Evacuees are encouraged to use housing options other than the emergency shelters if they are available in order to maintain room in the public shelters.

- **Sonoma County Fairgrounds** 1350 Bennett Valley Rd, Santa Rosa (**Accepting evacuees and small animals, not large animals**)
- **Marin County Fairgrounds** 10 Ave of the Flags, San Rafael (**Opens at 8am**)
- **Petaluma Fairgrounds** 100 Fairgrounds Dr, Petaluma (**Large animals only, no evacuees**)

### MENTAL HEALTH RESOURCES

### POWER SHUTDOWN AND RESTORATION

PG&E began power shutdowns the afternoon of Saturday, Oct. 26. Power is scheduled to remain off of affected areas through Monday, Oct. 28. ### TRANSPORTATION AND ROAD CLOSURES

- Hwy 101 northbound at Hopper Ave is closed in northern Santa Rosa and SB 101 at Cloverdale Blvd South in Cloverdale. The highway will be closed indefinitely.
