SECTION 1 INTRODUCTION

The City of Sonoma invites qualified Arborists to submit a proposal to update the tree inventory and health assessment of the trees located in the City's Plaza Park.

Background: The City of Sonoma has twelve (12) public parks and periodically conducts health assessments of the trees therein to prioritize maintenance needs and immediate hazards. Previously the City contracted with MacNair & Assoc to conduct such a survey of the trees located within the City's Plaza Park and produce a risk assessment with the results as attached in Exhibit C.

Scope of Services: The Contractor shall conduct a tree inventory based on the survey conducted previously. Contractor will update the tree inventory and update the health evaluations and risk assessment of the trees therein. Evaluation should consider overall health, structural stability, impacts, and sustainability of the tree. A sample City Professional Services Agreement is included as Attachment A. A list of trees assessed completed at Plaza Park previously and maintenance recommendation included as Exhibit B.

SECTION 2 CONTENTS OF PROPOSAL

To maintain uniformity in the evaluation process, proposal length is limited to a maximum of 10 pages on single-sided, 8½" x 11" paper. Use text font (ARIAL, TAHOMA, or similar) size 11 or larger. The cover letter, table of contents, front and back covers, and section dividers and resumes are excluded from the page count.

The Proposal Package must include following:

a) Cover Letter

Include the primary contractor's name and business address, as well as the project manager's name, telephone number and email address. Summarize your understanding of the project and demonstrate expertise that would meet the minimum qualifications laid out in Section 2(g). The cover letter shall be

signed by the person authorized to negotiate a contract for proposed services with the City of Sonoma on behalf of submitting firm.

b) Relevant Project Experience

Describe your team's experience on projects of a similar nature to this Project. Provide a project description, services provided, rates, the project's total cost, and references.

c) Scope of Services

Confirm acceptance of the proposed scope of services and identify any changes from the scope herein and in Exhibit B.

d) Assessment Methodology

Describe the methodology the Arborist proposes to use to inventory the trees as well as ascertain the health, structural stability, infrastructure impacts, and sustainability of the trees (i.e Resistograph methodology or similar)

e) Report

Describe the final report and recommendations the City can expect from the Arborist. Include any maps, inventory lists, or other descriptive products that the City might expect to see to understand the findings

f) Schedule

Schedule to complete inventory as well as assessments.

g) Required Certifications and Minimum Qualifications (not included in page count)

Included with proposal the following documentation for review.

- ISA Arborist Certification
- Valid Contractor's License
- City of Sonoma business license
- Insurable for coverage limits for Commercial General and Automobile Liabilities and Workers Compensation and Employers Liability as required as described in Attachment A.

h) Proposed Fee Schedule

Provide pricing to update the included tree survey and health assessment for Plaza Park. Provide any other necessary pricing and description.
