Sonoma's Tuesday Night Market 2024 Event Information

- The main focus of Sonoma's Tuesday Night Market (STNM) is making fresh, healthy, locally grown produce from small-scale farmers available to our community. And provide a community gathering place for our residents of Sonoma Valley.
- A limited number of non-profit "free speech tables" vendors may be selected to enhance the Market and complement the artisan, food and farmer vendors. In evaluating non-profit "free speech tables" vendor applications to STNM, we consider the following criteria: Previous participation, locally-based; certificate of insurance on file with the proper indemnifications, compliance with all applicable local, county and state ordinances and permitting.
- All accepted non-profit "free speech table" vendors must read and comply with the Sonoma's Tuesday Night Market Rules and Regulations found on the vendor page, at www.sonomastuesdaynightmarket.com.
- Please complete the applications and submit the application and certificate of insurance to the City of Sonoma Attn: STNM at least two weeks in advance of desired participation date. By submitting the application, it does not guarantee participation in the next market. Participation is limited and based on first come first serve onsite. Approved non-profit "free speech tables" vendors will be allowed to show up and claim one of the five locations reserved for non-profit "free speech tables" 30 minutes prior to the start of the market.
- Enclose your \$45 application fee payment! Applications without the \$45 application fee will not be considered!
 - The Market will close July 2, 2024 and July 30, 2024 due to conflicting events in the Plaza.

Important Notes for 2024

- ❖ Please note: effective March 1, 2019 the use of single use plastics at Plaza events is prohibited. This includes all plastic beverage containers (bottled water), *plastic bags*, plastic items i.e. toys, utensils, plastic plates and cups. There are a variety of plant-based paper products and compostable produce bags that can be used. Local retailers will be posted on our website.
- The non-profit participation is designed to be a messaging opportunity. Please do not bring items to sell or hand out to the public.
