Reports/Communications from Depts/Boards/Commissions

Chief Reinholz said the department had started the company safety inspections to look for violations and educate the business owners on safety issues. It was mentioned that the Fire Department visited Motel 6 often (169 times in 2023) because of issues with their alarm system that could not be updated, etc. Chief Reinholz also mentioned a tragic head-on collision on SR 43 last Thursday morning. The department had been busy with a lot of EMS calls; no major fires. He thanked Council for the support of the SAFER Grant application, and wished everyone Happy Easter.

Mr. Mytinger thanked everyone for attending the Community Center Ribbon Cutting last week; there was a great attendance for that. He said the Center was open for business and they would be taking rental reservations starting next month. Mr. Mytinger announced it was only 13 days until the Total Eclipse in the Park event on April 8, 2024 and activities were planned from 11 a.m. to 4 p.m. He confirmed for Mr. Michniak that the eclipse glasses they were distributing at the park were from the Great Lakes Science Center and were approved for looking at the sun. He and his staff had tested them. People were to not use sunglasses or their phones. It was still too soon to predict the weather for that day, but everyone hoped it would be clear weather.

Chief Wain thanked Council for letting them swear in Mika prior to the meetings tonight. It was very exciting to have Mika be part of the Streetsboro PD family. Mika came from a fallen officer's K-9 from 15 years ago with the help of science. Chief Wain mentioned that the PD was staffed heavy for the eclipse weekend because the campgrounds and hotels were full of visitors for the exciting once-in-a-lifetime event. Everyone needed to plan ahead, be safe, park in a parking lot, not along the streets. Mr. Michniak mentioned that the County courthouse was closing at noon that day so the staff could watch the eclipse event with their families. Mayor Broska said the City staff could take vacation time to see the eclipse that afternoon, if they wanted.

Mr. O'Malia said it would be Community Development Block Grant time soon, and he would be sending emails with further details.

Mayor's Report

Mayor Broska had provided Council a copy of the State of the City Report that he had presented to the Chamber of Commerce last Thursday morning (see attached). He thanked everyone that had attended the breakfast presentation; it was nice having it at the new Community Center. There were about 80 people in attendance. He also thanked everyone that had attended the Community Center Ribbon Cutting ceremony and Open House the night before.

Mayor Broska said there had been a lot of planning to prepare for the upcoming eclipse. Capt. Grimm had worked with the EMA and the local police and fire departments to come up with a solid plan to handle the influx of people that day. The police and fire departments would have extra staff on hand that day. All the hotels and campgrounds would be very full that weekend and Mayor Broska looked forward to the boost to the economy from all the visitors to the area. He wished everyone Happy Easter.

President of Council's Comments

Mr. Michniak commented that the Community Center looked better in person at the Open House last week; it was a very nice facility. The renderings and social media videos did not do it justice; it did not disappoint. Mr. Mytinger noted that they were still working on a pool table policy for fair use of the equipment. The Senior Center closed at 3 p.m. so any evening hours use of the pool table would be for programmed classes/activities, not "open gym."

Council Members' Comments

The Council Members wished everyone a Happy Easter and praised the new Community Center building. Mr. Ring said he'd noticed a lot of Sheriff vehicles patrolling for traffic enforcement in Streetsboro and asked about it. He thought the Sheriff should be patrolling townships and let the cities use their own officers. Mayor Broska said he supported the Ohio State Patrol and the County Sheriff department patrolling in Streetsboro to encourage less speeding and to potentially get drug traffickers off the streets. The visibility of any peace officer helped deter law breakers, which he encouraged. Mr. Michniak added that the route off the Turnpike was a funnel for drugs to enter our County and the Sheriff's department was "running dope" more so than any speed control.

Mrs. McDaniel thanked Bill Miller for handling a resident's problem quickly and efficiently. Ms. Wagner was pleased that Streetsboro had taken on Mika, a descendant of Twinsburg police officer, Josh Miktarian's K-9, Bagio, that Ms. Wagner worked closely with as the Police Dispatcher in Twinsburg. She had loved working with Bagio and was glad Streetsboro now had a close link to the fallen Twinsburg officer.
