# <u>Increase Board of Control Approval for Advantech fro \$7,000 to \$13,000 for Vehicle Parts and Supplies</u>

Chief Reinholz indicated that right now the limit is \$7,000.00 We have \$2,109.34 for repairs and miscellaneous parts and this will put us over the \$7,000.00. We have \$6,000.00 remaining in Vehicle Parts and Supplies. So the \$7,000 and the \$6,000 is \$13,000, if something happens between now and the end of the year, it means I have to go back to Board of Control, hold a special meeting, not that we are going to spend it, the money is in the line item, that's the total amount left over after we purchase this. So we will just go for \$13,000 and if something happens the money is there to fix the rigs and we won't have to go to Board of Control or Council to get approval.

### Wertz Geotechnical Engineering, Inc. Pavement Cores for Ferguson Road

The Mayor indicated that Engineering is doing a project our on Ferguson Road and would like Wertz to do some pavement cores on Ferguson Road. The project cost for this is \$4,950.00. Engineering indicates that this project cost along with a previous P.O. for Wertz for \$1,200.00 will bring the funds to \$6,150.00. Engineering requests the funds from 101.43.5338. Matt Miller said this was flagged because we only have blanket coverage with GPD and QCI. We do not have it with Wertz Engineering so the aggregate went over the Board of Control limit so he is having Engineering bring this to the Board so they could get approval.

Mr. Bill Miller requested approval of expenditures up to \$19,000.00 for the demolition of the cemetery barn that burned. He said it was for safety reasons and to get what was left of the building cleaned up and inspect the concrete pad once it's cleaned up to see if it can be salvaged. Mr. Miller would like to get this finished and cleaned up due to the huge safety risk.
