Disposition of Minutes

Board of Control Meeting of November 13, 2024.

MOTION: TO APPROVE THE BOARD OF CONTROL MEETING MINUTES OF November 13, 2024 AS WRITTEN.

Moved by Bill Miller, seconded by Matt Miller. Upon voice vote, **motion carried**.

Contract with Harner Plumbing for 6 water meter replumbing.

Mr. Bill Miller stated that these were the last of the commercial meters that EJP and the other company could not get to. We would not be charged by them and Harner would get them done and we would pay them. We are coming to the end, other than the vacant buildings.

2025 Ohio EPA Water System License

Katie Harrison stated that this is the invoice for the 2025 Ohio EPA Public Water System License Notice. She asked that the Board approve \$7,267.56 to be paid out of 501.52.5339 so that this could be paid in January 2025.

<u>Contract with Mrs Electric, Oscar Brugmann and Ohio Edison for Electrical Service at</u> Floyd North Bicentennial Park

Mr. Mytinger stated that this what will be needed to get electricity to the pavilion and the park. Purchases will be from 401.32.5773. The expenditure will be in 2024 but the work will be done in 2025. The overall cost is \$13,000. Parks will work with the service department to run conduit and lines and then they wait on First Energy to drop the pole and pull the line up to a transformer and once it is up to the transformer then our contracted electrician can make the final connections.

MOTION: TO APPROVE THE EXPENDITURES FOR ELECTRICAL SERVICE AT FLOYD NORTH BICENTENNIAL PARK
