Disposition of Minutes

Moral Claim Regarding Damage to Land Rover Vehicle

Bill Miller said this damage happened when they were crack sealing on Kirby Lane. The flagger directed the gentleman around and when the driver turned his wheel it threw crack sealer and stone up on the side of his vehicle and caused some damage/scratches. There was an email this morning from the driver also asking for reimbursement of the rental car cost (\$453.20) while the Land Rover was being repaired. Matt Miller said the Board needed to include that amount along with the \$2,864.20 for the repair. Matt Miller said they would include the total amount in the Moral Claim Settlement and Full Release of Liability letter. Bill Miller said he had explained the Release Letter to the driver and would get it to him for his signature as soon as possible.
