Mayor's Report

Mayor Broska gave an update regarding the new fire station. At the last meeting the administration had with the proposed construction company, there was an issue with wetlands. Mayor Broska had contacted the Army Corps of Engineers and they finally were able to come out and inspect the property and it seems everything will be OK. The City still needed to answer a few questions, but the .04 acre of wetland would be protected. Mayor Broska hoped that they would be able to bring something forward by the February Finance Committee Meeting and be on track to start construction on the new fire station in early spring 2020.

President of Council's Comments

Mr. Ruediger told everyone to drive carefully tonight because the weather report indicated a very heavy fog tonight. He also wished everyone a Happy Valentine's Day this weekend.

Council Members' Comments

Mr. Ring thanked the Mayor and the administration for having more items go through three readings and fewer items of emergency legislation on tonight's Council agenda.

Mr. Lampa thanked THRIVE for putting on a great performance for "Art Knows No Boundaries" this weekend. He reminded everyone the State of the City address would be Wednesday, February 12, 2020 from 11:30 - 1:30 at the Chamber Luncheon. Mr. Lampa had requested to get more updates from the department heads and he decided to request a report from an individual director during his Council Members' Comments. He asked Mr. Mytinger to give an update regarding the Senior van tonight. Mr. Mytinger reported that the purchase of a used multi-passenger van for the Senior Center to transport Seniors to various events was on pause until he could hire a Senior Center Activities Coordinator to utilize the vehicle to its full potential. The Department still had the current van so they were not without a vehicle; the money budgeted for the van would still be used this year. Once the Parks and Recreation Fee Policy was updated, people would be able to purchase trees and benches for dedication and the Hometown Hero Banners. Mr. Lampa wished everyone Happy Valentine's Day.

Mr. Kocisko asked for an update on the City-wide signalization project. Mayor Broska said it was still moving forward. They were installing the traffic signals on the various poles this week (34 sets of signals) and the next step would be to widen the lanes where needed and restripe the lanes where reconfiguring of intersections was needed. Then there would be testing of the system. He expected the new signalization system to be working by the end of the summer. Mr. Kocisko complained that on Sunday morning the light at Superior and SR 14 was a problem. Mayor Broska said once the new signal system was started there would be a learning curve for the system to accumulate data and self-adjust to the environment/the actual use. The existing traffic controller was from 1994 and the new system would count cars and learn over time. The Police would still be able to manually adjust the lights near the school when there was a big event.

Mayor Broska clarified that there were three signals that were not part of this grant project because they were not warranted traffic lights: Kirby Drive and SR 303, Staples Drive and SR 14, and Diagonal Road and SR 14. The City would be able to keep all the galvanized poles that were coming down and they would be painted and repurposed to do the other intersections at City cost.

Mr. Hannan thanked the Service Department staff for a great job at snow and ice control this year; the roads have been maintained very well. He also thanked Terri Corbett for doing a great job with the customers at the Service Department.
