Chief Reinholz said the Parks and Recreation Department's Santa is Coming to Town program will be this Saturday with Santa on two fire trucks from 10 a.m. to 4 p.m. delivering gifts safely to children in Streetsboro. The air packs from the AFG grant had been received and the firefighters were training with them. Mr. Lampa commented that this grant equipment was the first item of news on the new City website, which would be activated soon. Chief Reinholz reported the Fire Department had assisted with the delivery of two babies over the last few weeks. The new fire station was moving along: the gas line was installed, the interior framing was almost done, the roofing was coming along. The building was approximately 65% complete and was on schedule. Chief Reinholz wished everyone a Merry Christmas.

Chief Wain asked the Council Member to let their constituents know that recently there had been a few thefts from unlocked vehicles and everyone should remember to lock their cars. This past weekend a scaled down version of Shop With A Cop was held. The officers that participated shopped for 10 families for food baskets and gifts for the children. She thanked the people and businesses that participated and provided money for the program this year.

Mr. Mytinger said Parks and Recreation would provide information tomorrow regarding the COVID-19 safety procedures this year for distributing the Santa is Coming to Town gifts so the families could provide a table or folding chair on the porch or in the driveway for Santa to drop off the gifts outside the home so the Santas/volunteers/firefighters would not come into contact with the families. Mayor's Report

Mayor Broska thanked all the City employees that donated gifts for the Streetsboro Community Christmas this year. He reported that the administration had been working for a few months to get the snow plowing/yard work program going for the Senior Citizens and disabled residents, but after a considerable delay by the State and some procedural delays it seemed they would not be able to do the snow plowing program this season. Portage County Regional Planning who administered the program for Streetsboro had to send out RFPs which takes time, plus a separate RFQ. They should have everything ready for grass mowing in the spring and snow plowing next year. The residents that qualify will be issued voucher packets that they can hand out to people who mow their grass or plow the snow, which they can then turn in for payment. Mr. O'Malia noted it had been a long and cumbersome process; the State had not even released the money to the County yet.

Mayor Broska wished everyone a Merry Christmas. Although it had been a stressful year dealing with the pandemic there was still a lot to be thankful for, and he looked forward to starting a new year. He congratulated Mr. Hannan and Mrs. Field for being elected as President and Vice President of Council and also congratulated the new Committee Chairs.

Mayor Broska said there was a term expiring this month on the Planning Commission. Brian Salyer had just been appointed to the seat a month or two ago to fill an unexpired term and Mayor Broska wanted to reappoint Mr. Salyer to the seat for the next 4 year term. Mayor Broska asked that Mr. Salyer be reappointed tonight without having to appear before Council since he had just been here a few weeks ago, and we were trying to limit in person attendance during the pandemic; and Mr. Salyer was currently under quarantine at home. Mr. Ruediger said Council preferred to have the candidates for appointment appear before Council, but Mr. Salyer had just been here, so Mr. Ruediger supported waiving that requirement for reappointment tonight.

He said he was sponsoring a holiday lighting contest again this year and the final day for voting on Facebook was on Sunday. Some local businesses had offered gift cards as prizes. He wished everyone Happy Holidays.

Council Members' Comments

The Council Members wished everyone Merry Christmas and Happy New Year. They each congratulated Mr. Hannan and Mrs. Field on their election as President and Vice President of Council. Mr. Lampa thanked City Hall for all the donations for the Community Christmas. He rented a 16' box truck to deliver all the gift to St. Joan of Arc on Wednesday and he and Josh Lampa would help Mrs. Danner arrange the gifts that day for the children. They were happy to fill in for the Schaeffer's this year who were dealing with health issues.

Mr. Lampa announced that the City's new website would launch on December 23, 2020 at 7:00 p.m. He said he worked with a great team at City Hall to get this accomplished. The consultant they worked with was impressed that the City met its deadline. He still needed to work with TTx to reconfigure servers and redirect things. Anyone with bookmarks from the old website, should check them after December 23 because some may be broken. Online bill pay will be available January 1, 2021. Mr. Hannan asked for a round of applause for Mr. Lampa for all his hard work on the Community Christmas and coordinating the new website

Mr. Ruediger mentioned for a resident that the timer for the Christmas lights at the NE corner of the square was not working properly. Mr. Mytinger said that timer had gone bad and was replaced today. Mr. Ruediger also mentioned for some residents that the traffic signal as you came out of Target to SR 303 needed a left turn arrow.

Mr. Ruediger noted a COVID-19 vaccine had just been approved and had started to be administered to American health care professionals and first responders today, but there was still a long way to go and everyone should continue to wear masks and wash their hands and be careful around others. Thousands of Americans were still dying every day and people close to the Council Members were currently affected. The hospitals were so busy some had difficulty taking care of every day accidents and illnesses, so continue to be very careful with this virus.

Mr. Ruediger wished everyone Happy Hanukkah and Merry Christmas.

Mr. Ring looked forward to the new year and hoped everyone would stay safe. He said he had COVID-19 and it was scary even though it was a mild case. He thanked Mike Lampa and Josh Lampa for their work with the Community Christmas because it was an important program for our community, especially in today's pandemic/economic situation.

Mr. Kocisko thanked everyone for the well-wishes and he wished everyone happy holiday, and he looked forward to next year.

Mrs. Field thanked everyone for electing her as Council Vice President. She mentioned that since all the Council Members had received new laptops with CARES money for teleconferencing, she wondered if she could no longer get a hard copy of the meeting packets and just use the laptop screen to view the packet at the meetings. The Council Clerk agreed to not provide her with a hard copy of the meeting packets. She wished everyone happy holidays since she would most likely not be at the next meeting. She said it was such a pleasure to work with so many generous, kind, professional, hard-working people throughout the whole City, especially during this difficult time. She appreciated being part of this great community and would be back for the meetings in 2021.

Mr. Hannan and Mr. Ring also preferred not to get hard copy packets. They explained that Adobe and OneNote allowed for notes and editing of the electronic version of the packet pieces.
