T-6832 Accept Donation of Masks from Permco

Mayor Broska said Permco had donated a large quantity of N95 masks and bandanas and this ordinance was to accept them. Mayor Broska said the City had been getting a lot of donations of safety supplies and Personal Protection Equipment (PPE) for the COVID-19 situation, including 30 hand-sewn masks from Gloria Yeager and may get more as this situation went on, so he asked if Council could do a blanket acceptance of the safety supplies for COVID-19 so the staff could use the equipment. Mrs. Kremer thought only items over a certain value had to be accepted, but Ms. Esarey thought all donated items should be documented as assets for the audit. Mr. Kocisko thought all donators should be recognized and the Mayor could prepare a list.

Mr. Kocisko mentioned that not everyone had a computer and could even access Zoom, but they should still be allowed to comment. Mr. Ring said they could always submit their comments to the Clerk by phone, email or even "snail" mail prior to the meetings. Mr. Ruediger and Mrs. Field agreed with these suggestions. Mr. Kocisko hoped to get back to in-person meetings at City Hall soon.
