Reports/Communications from Depts/Boards/Commissions

Chief Reinholz reported the Mayor swore in a part-timer today to join the Department. The Department was scheduled for the second COVID-19 vaccination in a couple weeks. Captain Grimm had distributed the social media calendar to Council with the list of seasonal educational items for 2021. The weekly run activities list was distributed. The yearly property loss was recorded at \$110,000, but the property saved was worth about \$831,000, so about 12% loss.

The Department was less busy in 2020 (by 50 calls) because when COVID-19 first started everyone stayed home and the run volume went down, people weren't calling for the Fire Department. Now in 2021 the run volume was up again; Chief Reinholz said he went on a COVID-19 call with respiratory problems today and yesterday.

Mr. Ring commented that he had called for the squad for himself about a week ago and felt he received a fantastic response; the guys were extremely professional and made him feel like he was in good hands, which he appreciated. He thanked the whole team for the positive experience in a scary situation.

Chief Reinholz said the new fire station was moving along. The opening date was scheduled for approximately April 17, 2021, but may be delayed slightly if the weather didn't warm up to

at least 50° to finish the outside coating on the building. Hammond Construction was planning a ribbon cutting ceremony.

Mr. Lampa asked when/how the local senior citizens could get the COVID-19 vaccine. Chief Reinholz said the Portage County Health Department had been administering the vaccine to the health professionals, but the communities were trying to convince the County to include the Police Departments as an essential service. The County was working on distributing the second dose. Once that was done the local EMS had already been trained how to give the shots but would need to make arrangements to keep the vaccine cold and could set things up to distribute the shots to seniors. The drug stores/CVS were taking care of the nursing homes. The Fire Department would communicate the situation to the public on their websites regarding vaccines for the senior citizens.

Mr. Miller announced the water bills had been mailed out today. The water meters were read on December 31, 2020, but the system didn't record the data, so the water meters were reread on January 4, 2021 and mailed today (January 11). He asked the Council Members to let him know when they received their bills because there had been issues/delays with the postal system in the past. He expected the postal service in Kent to do the bulk mail the same as last time and the bills should arrive to the customers in 2-3 days. The water customers will now be able to pay online if they want to.

Chief Wain mentioned that Josh Bartholomew was honored tonight with the CIT Officer of the Year Award in a virtual award ceremony, which was a great recognition for all the extra work he had put in in the mental health field. She said the Department would be back up to full staffing in about two weeks with a new officer (with about 15 year of experience) to be sworn in. As Chief Reinholz had said, the police departments had been bumped out of the prioritized vaccination list, so the police department would have to continue using the extra protocols they had been using in dealing with the public to keep the officers as safe and healthy as possible. Mr. Hannan suggested also recognizing and congratulating Officer Bartholomew at a future Council Meeting.

Mr. Hannan mentioned that the last time the Browns won a playoff game he was about two months old, so he had literally waited his whole life to see this. Mr. Hannan also wished the Ohio State Buckeyes well in the 2021 College Football Playoff National Championship football game against Alabama tonight. He appreciated it was a short meeting tonight and everyone could go watch the OSU game. [OSU 24 – Alabama 52]

Council Members' Comments

All the Council Members wished Mr. Ruediger Happy Birthday and said "Go Bucks!" Mr. Ruediger thanked everyone here and online for the good wishes.

Mr. Lampa reported that he and Mr. Hannan would meet with Rachel Miller in the Parks and Recreation Department soon regarding producing a year in review newsletter for the new City website. He noted that about 700 unique people had checked out the new website; he would also check to see what pages they were viewing. He mentioned there was a subscribe button on the bottom of the new home page to subscribe to Parks and Recreation and City newsletters. The Building Department had told him they were very pleased with how many people/contractors were registering and paying online because it saved the staff so much time.

Mr. Hannan said he'd like to see a joint Mayor-Council Newsletter to get more engaged with the community. Mr. O'Malia had told him he was interested in doing a newsletter to get some businesses involved.

Mr. Kocisko said he got his first computer about 20 years ago and he was amazed at how far things had progressed with the electronic meeting packets, and how the citizens could watch the livestream You Tube videos of the Council Meetings, and the online bill pay. He thanked Mr. Hannan and Mr. Lampa for their efforts to get these things done. He was excited to see what might happen in the next 10-15 years.
