

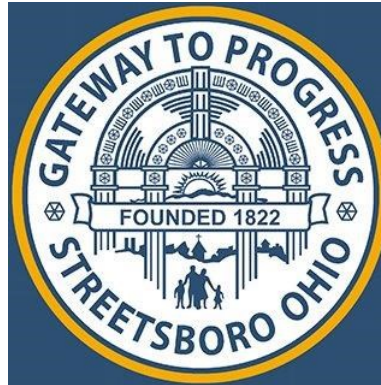
Program Rules

- Each resident requesting to participate in this program is required to complete and sign an application and release form provided by the City of Streetsboro and/or P.C. Regional Planning Commission. If a rental, homeowner must also sign release.
- Approved residents will be provided complimentary snow plow vouchers for the winter season. Vouchers may be used at the resident's discretion; however, once your vouchers are gone, no additional plows will be provided through this program.
- The address of the residence must be clearly visible from the road.
- Driveways must be asphalt or concrete to be plowed. **No gravel or grassed driveways can be plowed.**
- The contractor is required to plow edge to edge up to the obstruction. A walkway to house egress and steps will be shoveled. Salt will be applied to walkway, steps, drive and drive apron. The resident can request that no salt be applied.
- The contractor is free to plan their route and plow in an order most convenient to them. Contractor has 12 hours from the time of your call to begin job.
- The contractor is not liable for any damage to driveway, curbs, or lawn nor are they responsible for spring clean-up of any debris.
- Participants of this service must fully cooperate with the City of Streetsboro and the P.C. Regional Planning Commission. Abuse will result in termination of this service.
- This Program is dependent upon funding from the State of Ohio and the Department of Hous-

Am I Ready to Participate?

Once you have submitted your application and all of the required information, the P.C. Regional Planning Commission will contact you via US mail to confirm your eligibility.

If you are eligible, the letter will provide detailed instructions, approved contractor information and snow plow vouchers for the winter season.

Senior Snow Removal Program

Program Information

Senior Snow Removal Program

The City is proud to offer a Senior Snow Removal Program to assist residents most in need during the winter months.

The program is designed to help lower income residents get out of their homes for necessities such as prescriptions, religious services and/or medical appointments.

Approved residents will be given snow plow vouchers to use at their discretion during the 2021-2022 winter season, unless the State continues to allocate the resources.

Please do not use this program as your only means of having snow removed from your driveway. If it is necessary for you to leave home frequently, regardless of the weather, you should make arrangements with a private contractor to plow your driveway.

Do I Qualify?

Eligibility is based on age and/or a documented disability, income and full-time resident in the City. Owner/rental occupied single family and duplex homes and are eligible.

Income eligible applicants will either be:

Someone at least 65 years of age residing in the home as the legal owner or tenant.

Or

A resident living with a disability that prevents them from removing snow.

To be income eligible, the following guidelines apply:

If you are a one person household, your annual gross income (before taxes) must be at or below **\$42,750.**

If you are a two person household, your combined annual gross income (before taxes) must be at or below **\$48,850.**

If you are a three person household, your combined annual gross income (before taxes) must be at or below **\$54,950.**

In addition to documents verifying income, all applicants must provide:

Proof of age with a current Ohio Driver's License, State of Ohio ID card or Birth Certificate.

If disabled, a medical certification in the form of a letter from their physician as proof of disability.

Copy of current lease, if property is a rental.

Frequently Asked Questions

Q. I forgot to turn my application in on time and now it is snowing. May I still apply?

A. The P.C. Regional Planning Commission will only accept applications for a limited time. Please contact Lisa Reeves, CDBG Specialist, P.C. Regional Planning Commission at (330) 297-3613.

Q. Do I have to reapply to be in the program each year?

A. Yes. People move, circumstances change and we need to know if you are still income eligible.

Q. My driveway is not concrete or asphalt. Can I still get my approach/apron done?

A. No. This program is for a full driveway plow only.

Q. Can I use the contractor of my choice?

A. No. You must use the contractor listed in your eligibility letter.

Q. What if I misplace my vouchers?

A. Please take care not to misplace your vouchers. Treat them as you would cash. If you misplace your vouchers, the contractor will expect full payment at the time of services.

Q. What happens if I run out of vouchers but I need my driveway plowed?

A. Please use your vouchers carefully. If you run out of vouchers, the contractor will expect full payment at the time of services.

Q. What if I have a complaint about the driver or the way my driveway was plowed?

A. Please contact the contractor's main office and speak to a supervisor and contact the P.C. Regional Planning Commission..

Q. What if I call a contractor and no one answers?

A. Contact the P.C. Regional Planning Commission. Take pictures if appropriate for documentation.
