Disposition of Minutes

Monthly Financial Report

Ms. Esarey said the May financial reports were distributed on June 1, 2021. Overall the budget was looking good. The Building Plan Review Fees seemed to be a little high, so she anticipated a need for an amendment if it didn't even out after the busy season. The Overtime for snowplowing was coming down as the year progressed. The General Fund expenses including encumbrances was above target at 54%, Total expenses were also above target at 62% but the City was paying off the BANS so that affected it. The General Fund revenue was slightly above target at 45%, and Total revenue was at 55%. The June income tax reconciliation was above target [50%] at 55.6% and she hoped it would stay at or above target for the rest of the year.

New Business

T-7060 Amend Ord. No. 2021-35 Fire Station Contingency

Mr. Ring said he and Mr. Lampa had talked to Ms. Esarey and understood the issue for this item. Chief Reinholz explained this was a request for additional contingency funds for items that weren't completed when the fire station was built. He said they could do without these items, but would like the additional funds from Council to get it completed correctly. He had provided a list of items with costs [see attached]. Mrs. Field commented that Council wanted to do the fire station right and get the things that were needed. Chief Reinholz said it had been a very educational experience to build the station from scratch, which they could apply to future projects that the City may do regarding costs and procedures and what was really needed. The costs added up quickly.

T-7061 Authorize Payment of Right of Way Costs for SR 43 Corridor Project

Ms. Esarey said last year the City passed two ordinances: one to pay O.R. Colan and one to pay Bowman. These were to work out the right of way appraisals and work with the property owners for the SR 43 corridor project. Now the City was at the point where the agreements had been worked out and the City needed to pay the right of way costs; this would give the authorization to do that. The City would pay these costs 100% and then ODOT would reimburse the 90% per the agreement.

Ms. Esarey said most everything was ins and outs, except the \$40,000 transfer from the General Fund to the Capital Fund for the fire station additional contingency. Exhibit "B" was because the State of Ohio had just approved that the \$91,000 in the 704- Revolving Loan Fund could be used for the demolition of the old fire station, so this would allow the City to get a PO encumbered and then take care of the invoices as they came in for the demolition.
