#### **Mayor's Report**

Mayor Broska reported that Chagrin Valley Paving was tentatively scheduled to being the 2021 road paving program on July 12, 2021. Mayor Broska commented that Don Johnson of Kimble Company had asked if he should attend this evening regarding the trash and recycling contracts and the Mayor had not thought that he would need to attend because the City had been through this before and knew what was going on. Mayor Broska also noted that if Council had wanted to remove the mandatory participation in the recycling franchise, that would have taken a vote of Council. The administration could not have acted on Mr. Ring's comments regarding his preference that may have been stated at an administrative meeting about Portage County Recycling wanting to get out of recycling and had to act on the ordinances that were in place. Mayor Broska had not expected the amount of discussion regarding the trash and recycling topic that happened tonight. The packets of proposed legislation had been delivered last Wednesday and if any Council Members had questions or concerns, they could have contacted the Mayor before tonight.

## **President of Council's Comments**

Mr. Hannan noted there was a vacancy for the Vice Chair of the Finance Committee. He asked for volunteers for the position or he would take the position. Mr. Lombardo offered to take the position. Mr. Hannan appointed Anthony Lombardo as Vice Chair of the Finance Committee.

Mr. Hannan noted there were a couple Council absences expected at the July meetings, so he asked if the meetings should be rescheduled or combined to have maximum attendance. Mayor Broska noted three reading were needed for the trash and recycling legislation and the current trash contracted ended July 1. He hoped to keep the readings on schedule and keep to the quarterly billing schedule if Council approved the new agreement with Kimble with one month at the old rate and two months at the new rate. Mayor Broska would talk with Don Johnson, Kimble representative, in the morning to discuss Council's concerns mentioned tonight and would report back to Council. Mr. Ring felt combining all the committee meetings into one night would be too much but Mrs. Field noted that in 2020 there was only one meeting in July. Council decided to make no changes to the July meeting schedule at this time. Mr. Hannan wondered when the ability to vote over Zoom would end since most of the COVID-19 pandemic restrictions were ending this month. [Council Members could participate in meetings and discuss issues over Zoom, but voting in-person was required after July 1, 2021.]

# **Council Members' Comments**

Mr. Lampa asked what day the Thomas Heritage Park parking area would be paved. Mayor Broska didn't know, but it was part of the 2021 road paving program to start in July. Mr. Lampa said the pictures of the new fire station posted on Facebook looked stunning. Mr. Lampa reported that he, the Mayor, and Mr. O'Malia would do a program at the Senior Center

in August offering lunch and reviewing all the Senior programs the City was offering this year (lawn care, snow plowing, etc.). He said Happy Flag Day today.

Mr. Ring thanked everyone that participated in the Memorial Day events around town two weeks ago. He said the new Veterans' Memorial at Evergreen Cemetery look terrific and the Service Department had done a great job with it and the veterans appreciated it.

Mr. Kocisko thanked Mike and Josh Lampa for all the painting and flowers they did for the City.

Mr. Lombardo asked for some residents about handicapped parking at Thomas Heritage Park. Mayor Broska said there would be designated handicapped parking when the paving was completed. Mr. Mytinger added that currently there was gravel from the parking lot to the dog park. Mr. Lombardo said a few months ago his neighbor called the Streetsboro Fire Department and the ambulance responded quickly and the paramedics were very professional, so he thanked the Fire Department for doing a good job.

Mrs. Field asked about Mr. Lombardo, the new Council Member, getting a laptop like the other Council Members. Mayor Broska said the laptop of the previous Council Member was getting prepped (TTx would wipe the hard drive and reprogram it), then it would be delivered to Mr. Lombardo soon.
