Disposition of Minutes

Citizens' Comments

Reports/Communications from Depts/Boards/Commissions

Ms. Esarey said since the last meeting the administration had met with GPD to try to put together information and prioritization regarding how the City would use the stimulus monies, that were allowed, for the water projects. Once they had some detailed information it would be shared with Council so Council could finish their discussions regarding the water rates. She also mentioned that the stimulus money that might be coming in might be changed. SB 111 had introduced having townships receive money that would be taken out of the City distributions. It looked like Streetsboro's distribution (\$3.4 million) may be cut in half (\$1.7 million), but nothing had been finalized and the exact amount was not known. Streetsboro would get two distributions, but did not know yet what the final amount would be. Once that was known the administration could work out what could be done for the water projects.

Mayor Broska said when the administration heard about this SB 111 proposal, he called State Senator Jerry Cirino. Senator Cirino said the change was sent down by the feds and he had thought there was nothing the states could do about it, but he learned the states were going to look at it to maybe amend it, but they may run out of time because they still needed to get the budget passed and would go on summer break soon (June 30-September). The U.S. Senate had thought the townships should get some money for their population, but the Senate had not considered that townships don't have control of water systems or sewer systems or much responsibility for road maintenance and the cities did have to provide these services to their residents. The cities still needed to know how this was going to work out, as soon as possible, because the money had been expected in May and it was still not here yet.

Mr. Kocisko thought Streetsboro shouldn't talk about spending this money until it was in hand, just like the gas tax.

Chief Reinholz reported that the old fire station had been torn down and now people could see the new fire station better from SR 43 and there had been a lot of visitors come to tour the station. He said they started doing this year's fire extinguisher demonstrations. In the fall they would be doing inspections of the commercial businesses. The high school football games would be starting this fall and the ambulance would attend each home game. The Department had hired three new part-timers and had started training them. Bainbridge was having their trustee meeting tonight to authorize the paperwork for Streetsboro to get their old tanker, and then Chief Reinholz would bring the issue to the Streetsboro Safety Committee meeting on July 12, 2021. The Department had assisted Kent with mutual aid for a fire, and been on the local news for an incident on the Turnpike where a 2 x 4 went through a windshield right between the driver and her passenger. The Department would assist with the Woodside Lake Park fireworks this coming weekend. The finishing touches were coming along with the new fire station and would progress with the additional contingency money that would be authorized tonight. Chief Reinholz expected a ribbon cutting ceremony in early August.

Chief Wain reported that the police station elevator was now fixed; it had taken almost 7 months to get the proper sensors and get them installed. A full-time replacement officer had been hired and sworn in today. She asked that the Council Members remind their constituents to please lock their cars and put away the keys because neighboring communities have had a lot of cars stolen and thefts of things from inside of unlocked cars.
