Reports/Communications from Depts/Boards/Commissions

Chief Reinholz reported that an ambulance that had been sent out to be refurbished (instead of buying a new one) had come back. The Department was in the process of hiring 4 part-timers. Bainbridge should receive their new tanker in mid-August then Streetsboro would get Bainbridge's old tanker and send it out to be modified for Streetsboro; he hoped to get the tanker back by the end of September. There were a few things that needed fine tuned with the new fire station; they were having difficulty getting contractors to come do the work, but the concrete had been fixed and water was no longer puddling. Trees had been planted by the Parks and Recreation Department staff. The 9-11 Memorial looked fantastic at night with the lights on thanks to the Service Department staff. On August 3, 2021 there would be a luncheon for the Seniors at the fire station with the food donated by Giant Eagle. On September 10, 2021 the Chamber of Commerce would hold their luncheon at the fire station. The weekly activity log included photos of the recent preschool groups that had visited the fire station. There had been a lot of visitors with their children stop to see the new fire station. Chief Reinholz

thanked the Mayor and Council for their support in getting the new fire station. The ribbon cutting would be Saturday, August 14, 2021 at 10 a.m. and a flyer would be out soon.

Mr. Cieszkowski reported there would be a Planning Commission Work Session regarding the Core Concept Plan Design Guidelines and Zoning Regulations on Wednesday, July 28, 2021 at 7 p.m. No action will be taken at the Work Session, but the consultants will be there to present the plan, provide an overview of the zoning and design guidelines, and answer any questions the Planning Commission Members may have. The meeting was open to the public.

Mr. Mytinger said he'd been approached by some community members who were interested in partnering with the Parks and Recreation Department to offer a 20 year memorial run/race for the 20th anniversary of September 11, 2001. The race would be 9.11 miles on Saturday morning, September 11, 2021 about 6 a.m. People could run solo or do a team relay of three runners of 2-3-4 miles. The Police Department, Service Department and Fire Department had been consulted. Any proceeds after expenses were covered would go to the Streetsboro Police and Fire Associations. Mr. Mytinger said they would need about 30-35 volunteers for that morning and planned to be done before the 9:50 a.m. Memorial Service at the Fire Station.

The Council President moved the Mayor's Report up on the agenda so the Mayor's appointee did not have to stay so late.

Mayor's Report

Mayor Broska asked to re-appoint Dick Rynearson to the Parks, Recreation and Conservation Advisory Committee (PRCAC). This would be Mr. Rynearson's third term on PRCAC and he had been a valuable member with good input over the years. Mr. Lampa thanked Mr. Rynearson for all he did for PRCAC. Mr. Rynearson said he'd been very fortunate to be involved with this committee. He added that Mr. Mytinger and his staff were really wonderful, but overworked. Despite the work overload they continued to come up with a lot of progressive ideas and needed to be commended. Mayor Broska said the administration realized they worked very hard.

Phase 2, Aurora-Hudson Road and Wellman Road was started already, then Phase 3 would start, and then the final coat for all 19 streets and Thomas Heritage Park would be done sometime in early or mid-September. The Service Department would also be working on repairs needed on other roads.
