**Special Business**

**T-7058 ODOT Legislation for Southbound Lane on SR 14 between Price Road and Lake Rockwell Road**

Mayor Broska said this was enabling legislation for ODOT to move forward with this safety project on "Falcon Hill." This area had been the scene of many accidents and multiple fatalities over the years due to speed and/or people trying to turn left onto Price Road or left onto Lake Rockwell Road. ODOT would reduce the road from 4 lanes to 2 lanes (one lane in each direction) with deceleration lanes and a dedicated turn lane eastbound to turn onto Price Road and a dedicated turn lane onto Lake Rockwell Road. Coming from Ravenna westbound there would be a deceleration lane into Lake Rockwell Road and a deceleration lane to turn into Price Road, and also a left turn lane onto Lake Rockwell Road. He thought this was a great project that was long overdue. He asked for Council's permission to submit this to ODOT to begin the process for this project.

He emphasized that this project would be 100% paid for by ODOT with safety money because the area was a hazard that needed to be corrected. The only cost to the City would be if the City wanted something different, but he did not foresee the City wanting anything different.

T-7059 Agreement with ODOT to Resurface Frost Road from Philipp Parkway to Sunny Lane

Mayor Broska said this was more enabling legislation for ODOT. He said AMATS had some extra Transportation/Resurfacing Funds and asked municipalities if they had anything that was shovel ready. Frost Road had been done 8 or 9 years ago and at that time the City knew there might be some subsurface issues, and that resurfacing had not had the duration that the City would like out of a paving program. So along with this resurfacing they would also do some subsurface repairs and stabilize the road a little more, similar to what had been done with Fairacres Avenue 2-3 years ago. When roads were installed 50-60 years ago, not a lot of thought was put into the base, so some roads were having stabilization issues now.

This project was to be paid 80% by the State (AMATS) and 20% by the City, which was normal for a resurfacing project. This would be part of the 2022 budget. The total project was to be about \$850,000 with about \$170,000 as the City's portion. Ms. Esarey noted the City also had to pay \$15,000 in 2021 because ODOT would not cover any engineering for the project.

Mr. Kocisko wondered if there were any waterlines to be replaced in this area so a new road would not have to be torn up when the waterline projects were done in the next two years. Mr. Miller did not think there were any waterlines involved along Frost Road.
