#### Clerk Correction

Mrs. Kremer explained that Ord. No. 2021-118 was passed by City Council on August 9, 2021. It was a 7 page document regarding Site Development Regulations and there had been an oversight on page six. # Mayor's Report

Mayor Broska said the 9-11 Memorial Service went very well and there was a large crowd. The Memorial, moved from the old fire station and reconstructed by the Service Department, looked phenomenal and the Service Department had done an excellent job placing the piece of beam from the Twin Towers and building the Memorial. Those that stayed for the open house and toured the new fire station loved it.

Mayor Broska said he was taken aback by the Juneteenth item not passing considering the National and State governments had both adopted it.

## **President of Council's Comments**

Mr. Hannan said he had not been able to attend the 9-11 Memorial Service this year because he had a Cross Country meet with his team that morning, but he saw pictures and comments online and was glad it went well with a large turn-out.

## **Council Members' Comments**

Mr. Lampa said the 9-11 ceremony this year with the singers and the Mayor's phenomenal speech about unity was very emotional for him. He said the speech brought it to the forefront that this City is missing unity. Then he reminded Council Members that any personal feeling should be kept out of voting. He was also taken aback that Council had not passed the Juneteenth holiday. He thought Mrs. Field's No vote was a personal feeling. The unions and the government had already asked to make that a holiday and he felt her vote was uncalled for.

Mr. Lampa thanked Mr. Lombardo for following up with the Forest Valley issues; the ponds had been cleaned up.

Mr. Ring said he was also impressed with the turn-out at the 9-11 Memorial Service; it was the 20<sup>th</sup> anniversary of the September 11, 2001 terrorist attacks.

Mr. Kocisko said he'd been on a lot of Councils over the years and felt this City Council was unified. He was impressed and happy to be part of this Council. The members had differences on various issues, but still worked together and treated each other as friends. He felt there was a lot of unity between the Mayor, directors, and Council Members and although there would still be disagreements over issues, they were all still friends.

Mrs. Field understood the comments tonight. She said, to her, there was a difference between personal feelings and personal convictions and while others may not understand where she was coming from, or may disagree where she was coming from, she would always put here convictions before her feelings. She added that she was sure the ordinance regarding Juneteenth would pass when Mr. Lombardo was at the meeting and it would be taken care of.
