T-7107 Authorize Contract for FD Annual Physicals

Chief Reinholz said it was the time of year for the annual physicals. The Department had been doing them for a few years now according to the collective bargaining agreement. Quotes had been received from a few different medical companies that provide physicals. Chief Reinholz recommended Unity; the Fire Department had used them for a couple of years and were very happy with their service. Unity actually came to the Fire Department to do some of the procedures so the firefighters didn't have to leave the station. These quotes included special heavy metal testing, etc.

T-7108 Amend Ord. No. 2020-142 Air Cylinder Fill Station

Chief Reinholz said the Fire Department had purchased the air cylinder fill station to fill the cylinders the firefighters carry on their backs with compressed air back in December 2020, but it was just delivered 2-3 weeks ago. The Department had purchased it from Finley Fire Equipment, but due to all the delays, by the time it was delivered, Finley had been bought out by Atlantic Emergency Equipment. So now he needed authorization to pay Atlantic Emergency Equipment for the air cylinder fill station and the price was an additional \$4.06 due to some additional brackets/fittings. He asked Council to amend the original ordinance so he could finish this purchase.
