Certification of Water Rates for 2022

Mr. Miller said this was done annually based off the existing ordinances. There would be a 3.5% increase for 2022 which was the annual 2% increase plus 1.5%. Ms. Esarey had contacted Portage County Water Resources and learned they had no planned increases for 2022. Mrs. Harrison had also contacted Portage County Water Resources and confirmed there were no County increases for 2022 (which the City would have passed on if there were any). There was no Council action needed. The Clerk explained that the Finance Director was required to annually certify the rates for the next year to Council before they could take effect and this agenda item was just to record and document that was done.

T-7164 Pay Annual CMI Hardware and Software Maintenance Fees

Mrs. Lockhart-Reese said this was for the annual contract renewal with CMI, which was for the Finance and Water Department's hardware and programming maintenance. The quote had been

included in Council's meeting packet. She asked that it be passed as emergency legislation as soon as possible to pay the rates/fee for 2022. There was a slight increase in the costs for the new year.

Moved by Mr. Lombardo, seconded by Mr. Lampa. Upon voice vote, **motion carried**. There were not enough Council Members present to pass this item as emergency legislation tonight, but it could get first reading tonight, and then be voted on as emergency legislation at the January 10, 2022 Regular Council Meeting.

T-7165 Contract w/ADP for Payroll Services

Mrs. Lockhart-Reese asked that this item be forwarded to the January 10, 2022 Regular Council Meeting because she had not received the updated quote from ADP yet. They had agreed to hold the rates at 0%, 0%, and 2% increases over the next three years, but she didn't have the written quote yet.
