New Business

T-7146 Accept Donation of \$1,000 for FD

Chief Reinholz said the Department was surprised a week or so ago when Home Depot delivered a big cardboard \$1,000 check. The Department was appreciative and grateful for the donation; they would use the money for tools, that they hoped to buy at Home Depot. Chief Reinholz asked Council to accept the donation of \$1,000 from Home Depot.

T-7147 Amend Ord. No. 2021-93 Tanker

Chief Reinholz said this was for the tanker the Department had purchased from the Bainbridge Fire Department. It was finally received and was delivered to the auto body shop. The original quote had missed a couple of items: moving mirrors and repairing the old attachment location, and repairing the water tank rack struts. The additional cost would be \$9,444.24 for the labor for these repairs. There was money in the line item to cover this cost.

T-7159 Replace GETAC Rugged Tablets MDTs in Police Cruisers

Chief Wain explained these tablets were used as computers by the officers in the cruisers to maintain contact with Dispatch and each other. These tablets also ran the LEADS system and the Computer Aided Dispatch for the officers. After the Board of Control meeting last week, it was discovered that one of the 7 year old tablets quit working. There was a second tablet that had been failing. The Department had hoped it would last until 2022 to be included in a rotation schedule to change out the tablets, but the screen was pixelating and needed replaced sooner. This equipment was extremely important to the officers and she had found \$3,168.60 in a Capital equipment line and \$1,770.40 in the Tow Admin line for the total cost of \$4,946.00 to replace these two tablets. It was clarified later in the evening that no budget amendment would be needed; the funds in Tow Admin came from tow fees collected and could be spent on a variety of equipment and projects during the year.

Chief Wain explained that each cruiser had an MDT tablet and some that were less than 7 years old

had been replaced earlier in 2021 because they were having issues. These two were 7 years old and there may be one other that was 7 years old. She said the Department was trying to replace them as needed, and also create a replacement rotation schedule so they would not all have to be replaced at the same time.

MOTION: TO SEND T-7159 TO TONIGHT'S REGULAR COUNCIL MEETING AS EMERGENCY LEGISLATION.

Moved by Mr. Michniak, seconded by Mrs. Field. Upon voice vote, **motion carried.**
