## **Special Business**

## T-7156 Amend Ord. No. 2021-141 RLF for Mode of Expression

Mr. O'Malia said Council had met Heidi Grubaugh Ott, owner of Mode of Expression, in October. Ms. Grubaugh planned to buy the old Dairy Queen building on SR 14, and lease part of the building to Aria Nails who was losing their current space because Enterprise Rent A Car was taking over their whole plaza, so it was a nice opportunity to help two businesses at once. The resolution City Council had passed approved a loan between Heidi Ott/Mode of Expression and included the language that it was subject to approval by the State of Ohio because the State holds those funds. The State had approved the RLF but did so for the entity of 9081/9083 State Route LLC, which is an entity that Ms. Grubaugh Ott created to hold the title to the building. Therefore the City would need to update the resolution so the money was going to "9081/9083 State Route LLC" instead of "Heidi Grubaugh Ott," and also to explicitly give the Mayor the ability to wire the funds. According to Ohio law the City could not cut a live check because funds over \$10,000 had to be wire transferred. The Mayor would do the wire transfer of the funds tomorrow so they could close the sale ASAP. Council had already passed this once; this legislation was just an update.

Mr. Lampa commented that Ms. Grubaugh Ott was doing a phenomenal job with the building; the roof was already changed out and was looking good.

## T-7157 Insurance Endorsement for Tanker Engine

The Exhibit "C" was to create an account for the 9081/9083 State Route LLC RLF in order to release the funds.
