## T-7161 Authorize 2021 Transfers and Advances

Mrs. Lockhart-Reese said this was for all the transfers and advances made throughout 2021. This was required each year to be in compliance with the Ohio Revised Code 5705.14 for audit compliance.

### T-7162 Amend Ord. No. 2021-131 Replace Service Garage Concrete Floor

Mr. Miller said there was more work done, more floor was torn out, after the original ordinance was passed. Also Stamm's did not have the rebar for the floor so the Department had to go to Tucker Supply, and the Department had to get a couple concrete finishers to help finish the job. This project cost about \$13,000, but if the City would have had to bid the job out, it would have been over \$30,000; so it saved money for the City staff to do some of the work. Mr. Miller asked for emergency passage of this legislation tonight.
