# Reports/Communications from Depts/Boards/Commissions

Chief Reinholz said there had been a lot of activity lately. Capt. Grimm had done a great job distributing the activity reports and distributing pictures and videos of recent Fire Department events for public information. There was a fire on Gaynelle Avenue with a fatality. Chief Reinholz thanked the Police Department, the investigation detectives, and the Service Department for their assistance in locating the deceased individual in the collapsed home. The cause of the fire was still under investigation.

There was another fire on Stewart Drive caused by a candle. Chief Reinholz again thanked the Police Department for their assistance at the incident. Because of so many fires in the winter season, Channel 8 TV had asked for a segment on fire safety and Capt. Grimm and Mayor Broska were on TV8.

This past Friday there was a fire at the Happy Moose restaurant; a lot of damage, but no injuries. That fire was still under investigation.

The Fire Department assisted Mantua in a large fire. The Fire Department also delivered a baby this month during the heavy overnight MLK Day snowstorm. The department had been very busy this month; there were 17 calls yesterday. There was HAZMAT training, a medic refresher class and SCBA training this month. They would also try to arrange some training sessions at the old Arby's building (not live burns).

Mayor Broska commented that the fires on Gaynelle Avenue and on Flora Drive were both discovered by police officers on routine patrol in neighborhoods. These were examples of officers on routine patrol that resulted in them being the first calls for an emergency and kept things from being much worse. Residents often complain of not seeing officers on patrol enough, but the officers are out there doing their jobs.

Mr. O'Malia said the owner of the Happy Moose, Mr. Napier, was trying to recover from the recent fire and was looking for some temporary office space to get some work done. Mr. Napier was also looking to find some local contractors to help repair the restaurant. Mr. O'Malia was trying to find some financing structure, like the RLF used for the Mode of Expressions hair salon recently, to help the Happy Moose come back bigger and better if the insurance didn't totally cover the loss. Mr. O'Malia noted that the City staff had all been very kind and helpful, which Mr. Napier appreciated. Mr. O'Malia reminded Council that there was a Senior program available for snow plowing and hoped they would share that with their constituents.
