T-7167 Authorize Contract for Property and Casualty Insurance

Mrs. Lockhart-Reese had distributed the proposal from Love Insurance for the annual property and casualty insurance renewal. The City went with the same insurance company as last year, but changed the deductible from \$500 to \$1,000 which reduced the premium by about \$2,300.
