Mayor's Report

Mayor Broska reported, with the cooperation of Mr. Ring and VFW Post 9716 Streetsboro, there would be a new flag pole installed in the middle of City Park near the concession stand. There was a flag at the entrance to the park, but none inside the park. Mayor Broska had asked the VFW for a donation to defer the cost of a new 50' flag pole, but the VFW had generously agreed to cover the entire cost of putting up a new flag pole. A plaque would also be installed to recognize this generous donation. Mayor Broska would also have the City's IT Network Administrator do some research for a public address system that could be installed at the concession stand to play the National Anthem prior to any ball games. Mayor Broska still needed to determine the total cost of the flag pole installation, and the public address system.

Mayor Broska reported that brush pickup following the June 1 storm was still going on; there were a lot of limbs to pick up. He hoped the brush pickup would be done soon because it was delaying the spring road repairs the Service Department normally did this time of year.

The Mayor suggested Mr. Michniak, the Council liaison to the School Board, contact the School Board to arrange a meeting to discuss safety concerns and police officers in the schools as discussed earlier tonight in the Safety Committee Meeting.

President of Council's Comments

Mrs. Field thanked the VFW for the generous donation of a flag pole for City Park; she felt it was definitely needed. She also thanked Bill Miller and the Service Department staff for all their hard work for the City.

Council Members' Comments

The Council Members also thanked the Service Department for the storm clean up and the VFW for their donation. Ms. Wagner thanked the Mayor, Police Department and Fire Department for their follow up immediately after the storm too. Mr. Ring said the VFW had wanted to be more involved with the community and the flag pole project was a great opportunity to do so. Council Members wished all the dads Happy Father's Day this coming weekend. Mr. Lombardo appreciated the discussions tonight to see what everyone thought on all the different issues, and he liked the idea to meet with the School Board. Mr. Lampa thanked Jeramiah Greathouse for helping clean up some senior citizens' yards after the storm.
