# T-7265 Accept Donation of Car Wash Services for Police Department

Chief Wain explained the new car wash business in town, Sgt. Clean, had a standard practice to offer car wash services to the police vehicles of the cities they moved into. Sgt. Clean reached out recently to Lt. Beaver and offered that service to the Streetsboro Police Department. This would be a significant savings compared to what the department was paying now to Ultimate Wash. Chief Wain said Sgt. Clean did a really good job too.

Mr. Ring wondered if City Council had to officially accept this offer; there was no specific dollar value listed in the legislation. Mr. Beni said the State required the City to accept things valued over \$250, which this would accumulate to over \$250 quickly.

Chief Wain said Ultimate Wash was currently washing the police vehicles for \$10 per car, but it varied. The cost was hard to gauge because it depended on which cars were being used, how many officers were on the road, how bad the weather was, and the cost per wash. She mentioned that a

\$2,000 Purchase Order lasted for many months, but had expired and it would be good to get the cars washed for free. Sgt. Clean had indicated no limit to the number of police cars they would handle. Mr. Beni said a value did not need to be listed on the legislation, just "services" of an accumulated value over \$250 as indicated in the first Whereas.
