Mr. Cieszkowski reported the Master Plan Review Commission had its kick-off meeting and set the key stakeholder interviews for Tuesday, March 21, 2023. Mrs. Field suggested Michelle Bragg, a candidate for City Council, who was willing to be interviewed.

Chief Reinholz reported that the Fire Department had assisted with a lumber yard fire in Auburn/Middlefield. Last Friday there were multiple accidents on the Turnpike because of the weather. After the incident with the firefighter that had cardiac arrest at the station, the Mayor had requested that all the City staff get CPR and AED training. The Fire Department had recently completed that training for all the City departments.

Chief Wain thanked Council for doing the swearing in ceremony for the new Police Officer tonight. The Officer, Dylan Conant, was a local person with personal connections to the community and he would make a nice addition to the Police Department.

Mr. O'Malia reported there would be a Career Day this Wednesday, March 15, 2023 at the high school to recruit people to work at the local businesses for summer jobs or more permanent full-time positions and to promote their college tuition reimbursement programs.

Mayor's Report (continued)

Mayor Broska reported that the Gaynelle Avenue and SR 43 intersection had been opened because the gas line replacement project work zone was moving south down SR 43. The intersection at Apache Pass was still closed. They were still on schedule to be completed within

their 55 day time limit, and then Fechko would start about April 1, 2023 for the SR 43 road widening project for ODOT. Shelly would start work again on SR 14 on March 27, 2023 for about 60 days to finalize that project (sidewalks, top coat of asphalt, regrade and reseed). All the street lights from Portage Pointe Drive down to Diagonal Road would be replaced with LED lights that were brighter and less expensive. Mayor Broska mentioned that the traffic control during the SR 43 gas line replacement project had worked out pretty well compared to the traffic delay issues with SR 14 last year.

Mayor Broska mentioned that Leon Jankowski, a former Councilman, had passed away on February 25, 2023 and services were held last Friday at Shorts Funeral Home. Leon was a good guy and had been an integral member of the community over the years.

Mayor Broska also recognized Jerimiah Greathouse and Mike Kuhstos who had won Citizen of the Year awards from the Streetsboro Area Chamber of Commerce last week. He also noted Gebhardt Intralogistics North America received a Chamber Image Award, and Buckeye Quality Meets won Business of the Year.
